# Jr. Shooting Sports keeps producing scholarship winners

#### **By Tim Engstrom**

ANOKA — Megan Jaros has been in youth shooting for five years. Her father had been looking for an activity for her.

"None of the other sports were really sticking," she said.

The air rifle clicked — pun intended just a little — for the Mounds View High School senior. She is a member of the Minnesota Centershots, the American Legion Junior Shooting Sports team for Anoka Post 102.

Within a year and a half, she moved up from sporter class to precision class, which calls for more gear. At first, she borrowed a shooting suit, then had a custom one made two years ago.

She was leading at the American Legion 3-Position Air Rifle National Championship in Colorado Springs through three matches last summer, but she struggled in the fourth match ending up in fifth place. She placed first in kneeling.

Jaros will have a two-thirds scholarship at the University of Memphis this fall. Getting involved in Junior

# DEC approves resolution to broaden eligibilty for VA loans

Hassing said, when a member becomes department commander, they often think they are going to do all kinds of things, change what it means to be department commander, change the world. Hassing has traveled much of the state during his term.

"Then you get in the position, and you go, 'Wow! They don't tell you, and they can't tell you, how much it is," Hassing said.

The commander led the Department Executive Committee held March 2 at Montgomery Post 79. The committee approved two resolutions to be forwarded to the 105th American Legion National Convention Aug. 23-29 in New Orleans.

Resolution 2024-7 calls for legislation governing VA loans to broaden eligibility

MONTGOMERY — Commander Paul to include partners and co-habitants of veterans. This would allow their incomes to be considered in the loan application.

The resolution was brought forth by Department Service Officer Ray Kane and went to the 104th National Convention in Charlotte. There, the National VA&R Committee asked for a few minor changes and asked for its return this year.

Real estate agent Jon Haworth, a 4th District vice commander, assisted in bringing the original resolution. He said the resolution brings VA loans to be in line with the Minnesota Fair Housing Act and the laws of several states where it is illegal to discriminate against marital status.

# Sports betting bill calls for tax relief

# Charitable gambling could come out stronger by the end

ST PAUL — The American Legion Department of Minnesota, Allied Charities of Minnesota and the Minnesota Indian Gaming Association all are in support of a sports betting bill that would provide historic tax relief for charitable gambling.

The measure also allows posts to put more dollars from gambling proceeds toward maintenance of their buildings.

In the House, the bill is HF2000, and in the Senate, it is SF1949. It is authored by state Rep. Zack Stephenson of Coon

He testified at a hearing on Thursday, March 21, before the House State & Local Government Finance & Policy Committee on behalf of the amendment to add the tax cuts for charitable gambling to the sports betting bill. The state, he said, will be able to pay for the tax cuts through increased revenue from sports betting.

Stephenson was asked whether the tax relief will restore losses from electronic pulltabs (e-tabs) losing certain features —free plays, bonus games and open-all buttons — in the 2023 session to begin in 2025.

He said he disagrees whether the game changes or any losses will be as bad as purported. He noted revenue from pulltabs and e-tabs in Minnesota is split 50/50.

"This is a very good thing for the charities. They will be in a better position than they were before last year," Stephenson said.





# Tax cuts for charities is the top priority

Though most of us stopped wearing the uniform years ago, veterans have a deep-seated need to continue serving their communities. There are 537 American Legion posts throughout Minnesota, and 193 of them have charitable gambling operations. We use the funds to carry out our four pillars: Veterans Affairs & Rehabilitation, National Security, Children & Youth, and Americanism. That is why The American Legion Department of Minnesota fought the state Legmany other organizations with charitable gambling.

I totally agree. Many things change in each generation. In my day, the '40s and '50s, the word "drugs" meant going to the local drug store. The money trail meant putting pennies into the piggy bank. George Mikan, Mr. Basketball from the Minneapolis Lakers, earned \$25,000 a year. Now Mr. Basketball from the L.A. Lakers earns about \$48 million a year.

The "taking a knee" started a few years ago with pro sports athletes kneeling down. One pro football player started the long hair to the waist. Soon, the above and many other things changed and caught on both to

college and to junior and senior high schools. Coaches from all sports joined the money trail. College football players are changing schools and also refusing to play for a bowl game.

Who is to blame? Parents, teachers, principals, superintendents, school boards, the general public, or all of the above?

In my days, we were a one-car

family and also one driver. At the age of 6, I already had a Social Security card for all my after-school jobs. We brought shotguns to school and put them in our lockers with the OK from our teachers. We even had a rifle club at school.

In those years, World War II and the Korean War were going

on. With all that going on, no one ever thought of shooting or killing anybody. In the '50s and '60s, a church in our small town of 5,000 had 40 to 50 students who went to religious instruction every Wednesday and were confirmed. Now, the same church has seven or eight students being confirmed, and that's if they are lucky.

We were all taught to be respective to our elders. My 4-foot-9-inch grandmother ran the house. We had to be home by 6 p.m. for supper. If we were late, the next meal would be the next day at 6:45 a.m. My grandfather worked on the railroad, and the only driver of the house. That meant we all walked to school (12-14 blocks), work or play.

In the sports world, a large amount of students including my older brother and me would have participated, but we could not because of our jobs. Our coaches were great but also demanding both in sportsmanship and in appearance.

Standing for the national anthem? You had better believe that! Otherwise, you were no longer on any team — that also was Bud Grant's style.

Nowadays, at 2 to 3 p.m. each day after school, the TVs, computers and cellphones go into action. Social media takes over. Parents have allowed AK-15s and other guns to be unsecured in the house. Manners and respect are not present in the home and in our schools. Winning is more

important than anything else. Veterans Treatment Court.

If one follows pro sports, look at the money trail and the changes of coaches. The amazing thing is that the players earn more than the coaches! The pro sports arena has gone bananas with baseball players that are hitting .185 earning millions of dollars. The money trail is much more important than standing for the national anthem. This, to them and to the millions of students watching TV with their friends, is the priority that is passed on to our new generation.

My dad was in the Army during World War I. My older brothers was an artillery observer in the Korean War and in combat for two years. I spent six years in the Army during the Vietnam War. My three sons were all in the Navy for four years, which included the Persian Gulf War.

Maybe, in my opinion, we should go back to the military draft and that might make our children and generations more respectable — not only to our veterans but also to each other.

Again, thanks to Mr. Miller for his letter.

# ACM, MIGA, Legion stand behind HF2000, SF1949 sports betting bills

He fielded several questions related to horse racing in Minnesota. The committee approved his charitable gambling amendment on an 8-4 vote. The American Legion avoids partisanship, but it is worth noting the vote was not down party lines.

Some committee members sought another amendment friendly to horse tracks, but it failed. The bill gives licenses to the tribal casinos for the operation of sports betting, but it does not provide the means for the state's two horse racing tracks to conduct sports betting.

American Legion Department of Minnesota Legislative Chairwoman Kristy Janigo told the committee the Legion supports HF2000. She described how 193 posts and units have gambling licenses and tax cuts will help them in their mission, with things like honor guards, youth sports, suicide prevention, providing stop-gap funding for veterans in need, food shelves, fairs, fireworks, international sister-city programs, fire departments, schools, parks and more.

"Never before have we seen this level of tax cuts," Janigo

The provisions for making repairs or replacements to posts is necessary to prevent more veteran posts from closing in Minnesota, she said.

Gambling managers will want to know what the new proposed tax rates are. Taxes are paid monthly, and the rate is based on cumulative net receipts. As the months go by, the taxes are higher. Many urban organizations with busy bars zoom past the first three levels in the first

The present thresholds are: \$87,500 and under: 8 percent \$87,501 to \$122,500: \$7,000 plus 17 percent

\$122,501-\$157-500: \$12,950 plus 25 percent

\$157,501: \$21,700 plus 33.5

For the year between July 2025 and June 2026, the sports gambling bill lowers the percentages to 5.5, 15, 23 and 32.5 respectively.

For the year between July 2026 and June 2027, the bill lowers them to 4, 13, 20 and

Finally, for July 2027 and beyond, the bill lowers them to 3, 10, 18 and 26.

For post improvement, the expenditure is limited to 50 percent of profits from the previous fiscal year, allowing them to carry forward unused allowances (i.e.: savings) for two years to assist in the cost of major items, such as roof repair. They must identify the project to the state. The project must be within the existing building, not for a new building or expansion. It does not matter which part of the building is bar, restaurant, banquet, gambling, restrooms, offices or exterior.

Andy Platto is the executive director of the Minnesota Indian Gaming Association, which represents nine tribes. He spoke in support of the bill, which allows the tribes to run sports betting in Minnesota.

He thanked the veterans organizations and Allied Charities of Minnesota for their good-faith dialogue.

Speaking for the bill was Patrick Gibbs of the Coalition for May 20.

Fantasy Sports.

"We have more fantasy sports players per capita than any other state in the country," he said.

Stephenson said sports betting in Minnesota is a big issue that needs state supervision.

"Just because sports betting is illegal in Minnesota, it doesn't mean it doesn't happen in Minnesota," he told the committee.

The state rep told how it is easy to use an offshore website to bet on sports. The downside is there is no consumer protection, no taxes, nothing.

"The right approach is to regulate it, not stick our head in the sand," Stephenson said.

The committee moved to send the bill as amended to the Tax Committee.

In an email message to gambling managers statewide, Allied Charities of Minnesota wrote, "With this amendment, the updated version of the bill will include an additional \$40 million in tax relief for charitable gambling. Coupled with the existing \$15 million in tax relief charities received last year, the new amount will be \$55 million. Once fully implemented, it is projected that for the first time in recent years, charitable gambling organizations could earn and receive more funds to support their missions than they will pay to the state in taxes. The reduction in combined receipts tax rates will increase your profit on paper pulltabs, tipboards, electronic pulltabs and electronic bingo.

Nothing is written in stone, to be sure, and there are several weeks left in the session. The Minnesota Legislature adjourns

# **Ever wonder how Legion youth shooting works?**

According to the American Legion Headquarters in Indianapolis, there are five teams in Minnesota registered for the Legion's national tournament this year. Anoka Post 102 has two teams. The others are Redwood Falls Post 38, Pipestone Post 6 and Minneapolis-Richfield Post 435.

Post 102's Junior Shooting Sports crew is called the Minnesota Centershots. Post 435's team goes by X-Men. Post 6 is Pipestone County 4-H. Post 38 is registered as "38 4-H."

There are American Legion teams not participating in the national tournament. Forest City Post 225 is called "Gopher" because it is tied in with the local Gopher Rifle & Revolver Club. Houston Post 423 has the Houston Hurricanes. St. Thomas Academy has a youth-shooting team that isn't Legion-connected.

They all compete under rules set by the CMP — a national shooting organization with a focus on safe youth shooting called Civilian Marksmanship Program.

The program traces its roots to an age when the federal government encouraged rifle marksmanship among youth as part of national defense. It was originally called the National Board for the Promotion of Rifle Practice, or NBPRP, signed into existence by President Theodore Roosevelt in 1903. By 1907, national matches were held at Camp Perry, Ohio, though funding shortfalls sometimes led to cancellations.

In 1918, Franklin D. Roosevelt, during his time as assistant secretary of the Navy, was chairman of the NBPRP. By the Cold War, the program fell under the Department of the Army. In the 1960s, Army leaders concluded recruits could be taught adequately without civilian programs, and with some in Congress willing to defund gun-related programs, NBPRP struggled. In 1996, Congress spun it off as a federally chartered nonprofit called CMP.

The legislation stated, "In carrying out the Civilian Marksmanship Program, the corporation shall give priority to activities that benefit firearms safety, training and competition for youth and that reach as many youth participants as possible."

Visit its website "thecmp.org," and you find American Legion registration fairly swiftly under "youth."

Typically, photos of teams at competitions show them shooting indoors because they are firing air rifles that shoot the standard .177 pellet at tiny targets on the other side of the room. A common brand name is the Crossman Challenger. That said, teams at times compete outdoors in smallbore competitions, too.

Bill Buesseler is the head coach for the Centershots, and at the 2024 CMP 3PAR State Championship at Anoka Post 102 on March 16, he served as match director. There were 40 kids competing.

Buesseler said there are two classes in youth shooting: sporter and precision.

The sporter class competes with just the rifle, normal clothing and no acces-

a canvas and leather uniform and special accessories such as butt plates, weights and cheek pieces.

Precision class is what TV viewers see when they watch the Olympics.

A three-position air rifle (aka 3PAR) match is 60 shots, 20 from each position, with each shot right in the center worth 10 points, Buesseler said. The three positions are kneeling, prone and standing.

"Once a kid is achieving above a 450 score, we move them up to precision class,"

He said the Minnesota Centershots receive great support from Anoka Post 102, through its charitable gambling program, along with fundraisers and grants from Midway USA Foundation. Selling gear is one way to raise funds. A tan Minnesota Centershots/Anoka Post 102 T-shirt is \$12. A knife-and-flashlight kit is \$25.

"We really try to support new families and new shooters when they come into the club," Buesseler said.

Match fees are low, he said. The one in Anoka on March 16 was \$25. The prior tournament the Centershots were in was \$6. Some are free.

St. Thomas Academy won the sporter class team competition on March 16, followed by X-Men in second place. The champion of the sporter individuals was William Sellner of St. Thomas Academy, with a 517 score.

Jaros was the champ of the precision class among individuals. Her score was 591. The Centershots dominated the precision class team competition that day, with the Gophers in second place.

Jaros made it to the American Legion 3PAR National Championship in Colorado last year. Allison Buesseler went two years ago for the Centershots (and she hails from Forest Lake), and she is a junior at the University of Kentucky on the varsity shooting team.

Gavin Barnick of the Centershots made it three years ago, and now he competes for the University of West Virginia. In his first two years of eligibility, he competed for Alaska-Fairbanks and he guided them to an NCAA National Championship.

Just last month, the TCU Horned Frogs won the 2024 NCAA title, with West Virginia placing second, Alaska-Fairbanks third and Kentucky fourth. Garnick was the individual champ for air rifle.

Buesseler said posts can launch teams of their own by checking to see if any air rifle teams exist in their area, then asking if they want to participate in American Legion Junior Shooting Sports, too. Register teams at legion.org/shooting. Find more information at thecmp.org/youth/ american-legion/.

The resolution notes: "A substantial number of veterans are in committed relationships or cohabitate with individuals who, while not legally recognized as spouses, play a critical role in maintaining the household's economic well-being.'

Resolution 2024-6, written by Kane, calls on The American Legion to urge Congress to amend the Johnny Isakson and David P. Moe Veterans Health Care & Benefits Improvement Act of 2020. A change to that law could preserve burial benefits for veterans opting for a plaque or urn. Presently, they lose the options of a headstone or marker.

Kane gave a report on the Minnesota Veterans Assistance Fund. He said the fund has provided \$350,000 in assistance during its existence, with about \$2,348 per case on average. He thanked Assistant DSO Janet Lorenzo for her strength.

"Minnesota Veterans Assistance Fund is more than just a grant. It's a promise and a commitment to engage and embrace our veterans and a part of our community, a part of what I know now as family," Kane said.

He said it is critical that posts have connections to their county veteran service officers

In the effort to prevent veteran suicides, he and Lorenzo hope to have the VA S.A.V.E. training in all 10 districts of the Minnesota American Legion in 2024.

She said the Minnesota Legionnaires who visited D.C. spoke on supporting Afghan allies, supporting Gold Star spouses, support the expansion of Arlington Cemetery, paying the Coast Guard during government shutdowns, standing with veteran caregivers and stopping claim sharks.

Janigo noted Klobuchar was in an upbeat mood when receiving the award.

"She tends to be a very task-oriented lawmaker," Janigo said. "She was very happy, kind of jovial, joking with us, and just really appreciating being in the presence of Minnesota Legionnaires prior to getting nationally recognized."

At the state level, Janigo has been in the negotiations on charitable gambling, with hopes of delivering meaningful tax relief. She also mentioned a legislative networking event on Feb. 6 at Mancini's was well-attended.

"We had lawmakers from both sides of the aisle come visit us," she said.

#### Legionville

Legionville President Carl Moon said he has a wish list of items the camp needs.

# This World War II veteran served in the Forgotten Theater; now he is 100

BAGLEY — In 1924, you could buy a new house for \$7,720, a car for \$265 and gas was 11 cents per gallon. It was the first year New York City hosted the Macy's Thanksgiving Day Parade. Jimmy Carter was born that year, as was George H.W. Bush.

On Saturday, Feb 25, 2024, Irvin Blix American Legion Post 16 in Bagley was the setting where about 80 family and friends, from all over Minnesota, gathered to celebrated Eugene "Gene" Sandberg's 100th birthday. Sandberg, a Bagley resident, is a World War II veteran.

On Feb. 25, 1924, Eugene Axel Sandberg was born to Martin and Olive (Fredenburg) Sandberg in Bunker, south of Hibbing. He grew up in a section house on the railroad and went to a one-room school with one other family. Sandberg had three siblings.

He graduated from Hibbing High School, where he met his wife, Wilma

one month upon Sandberg returning from war. The couple had seven children; Barbara (Janesville), Christine (d.2000), Dale (d.1997), Kathryn (Bagley) and Raymond (Janesville). Scott and Gwendolyn died at birth.

Sandberg was in high school when Pearl Harbor was bombed. He was drafted into the Army in March 1943, induction date May 27, 1943, and began active service June 4, 1943.

Sandberg said that, when he enlisted, "three busloads of boys were brought down to Fort Snelling for physicals and then trained in New Orleans."

He left for war on Dec. 10, 1943, arriving Jan. 1, 1944 in India at the China-Burma-India Theater — the wars "Forgotten Theater." From there troops took a train to Calcutta, paddleboats upriver, then a 3-mile walk to another camp.

Sandberg left theater for his return to the States Oct. 27, 1945, arriving in New Jersey on Nov. 24, 1945. He said upon arriving back to the United States, (Chadwick), when he was 15. After his honorable discharge on Jan. 27, 1946, he worked on the Duluth,

Missabe and Iron Range Railroad for 21 years. He then moved to Janesville in 1963 and worked at Mankato State University as an engineer. In 1980, he moved to Bemidji to accept a job at Bemidji State University as chief engineer. He retired in 1987. In 2018, he moved to Bagley.

Sandberg was an avid hunter and trapper; he helped form the Trappers Association in Minnesota, was the vice president in 1959 and president 1959-1963. He also was a member of the Free Masons for 50 years.

Gene has 12 grandkids, 30 great-grandkids — plus one coming in August, and nine great-great-grandkids — plus one in July. Sandberg's "grands" are scattered all over Minnesota; Bagley, Janesville, Owatonna, Hallock, Nevis, Akeley, Kasson and

# 3 Purple Heart recipient attends Vets Day events

HOUSTON — "I got invited by a 12-year-old girl named Jaelyn Foellmi from Brownsville who goes to school at St. Mary's," said Dave Grahek, an area resident and a United States Army medic who earned three purple hearts in Vietnam. "It was such a nice letter, and I wanted to meet her."

So, he wrote her back and attended.

"He even took time off of deer hunting to come," said Grahek's wife, Carol, emphasizing the priority her husband made in coming to the event.

Grahek said he had also been invited to the Houston Elementary School program on Friday. He's a member of the Houston Post 423.

Grahek was drafted into the Army on Flag Day, June 14, 1965. He started with basic training at Fort Knox. Then he was sent to Fort Sam Houston in San Antonio, Texas for advanced individual training to become a combat medic, not thinking he was ever going to be one.

From there, his orders took him to Hawaii for 10 days, where he joined the 25th Division. He became a private first class with A Company, 1st Battalion (Mech), 5th Infantry, 25th Infantry Division.

"Next, I was over in Vietnam. In January 1966, we went over," said Grahek. They were stationed at a camp near Saigon.

#### **Purple Hearts**

From there, they started doing missions and were involved in a number of firefights.

"We got sniped a lot," said Grahek, who was there for less than a year. "We ate C-rations (now MREs) for meals. We were supposed to get hot meals, but by the time we got back, it wasn't hot."

Grahek doesn't know how, but he survived being wounded on three separate occasions a few months apart. The first one involved shrapnel in his body and a scratch on his eye. He feels lucky that he didn't lose his eye.

The second injury came when the armored personnel carrier that he was in was blown up.

"I don't know how I got out of that," said I was waking up 50 feet from the carrier. The one of the service branches after April 5, 1917, through the air and thought I was dead, so they wounded by enemy action.

Grahek ended up with a broken nose and cuts

'After the first two (injuries), it wasn't enough to be sent anywhere," recalled Grahek. "They did an X-ray and said I broke my nose, but they didn't do anything. I took care of it when

After the third injury, he had shrapnel in his hand and neck, but also would have a cast on his wrist for six weeks, which ultimately sent him home.

"Best words I ever heard: you're going home," said Grahek, as he visibly sighed.

#### **Coming home**

Upon return, he was sent to Fort Leonard Wood, Missouri, and there he was a non-combat medic. He started in the emergency room. Leadership thought they shouldn't have a Vietnam vet doing emergencies, so he became a shot team member and gave hundreds of shots.

He got out of the service on June 13, 1967.

He then married Carol, the girl back home who had waited for him, on Oct. 19, 1968. They just celebrated their 55th wedding anniversary, so he bought her an emerald bracelet (the gemstone for a 55th).

#### Life today

Grahek is an avid turkey and deer hunter, which originally brought the couple to the Caledonia area. They owned 80 acres up north, but there were no wild turkeys to hunt.

"So, we came to the wild turkey capital," he said. They built a home in Yucatan and lived there for 17 years before moving to Caledonia for a year. The couple now resides in Rushford.

While the memories aren't all happy, Gahek is proud of his service.

"A Purple Heart is something you never want to get," he said. "But I got three."

The Purple Heart Honor Roll shows his date of incident as May 23, 1966, with the status of wounded in action.

Currently, the Purple Heart, per regulation, is awarded in the name of the president of the United States to any member of the Armed Forces of the United States who, while serving Grahek. "I heard a great big explosion, and then under competent authority in any capacity with guys behind me in another carrier saw me fly has been wounded, killed or has died after being

Well, sorry, but that is not the bless our troops.







The following is an agreement made with the VFW in 2013 and agreed upon through 2025 for the seven-county metro area (Anoka, Hennepin, Washington, Ramsey, Carver, Scott and Dakota only). This information does not apply to units in any other county in Minnesota.

• Poppy Card Day (post home only) is April 18.

Poppy cards may be distributed within the confine of one's own post home to members and patrons only. Thursday evening, April 18, only if they are to be hung on the wall of the post home. No "distributed" poppy cards may leave the post home on Thursday.


