# Dept. looking at dues increase

### **Finance Committee** recommends \$3

ST. CLOUD — The Department of Minnesota Finance Committee recommended a state-level dues increase at its meeting Sept. 19 at Elk River Post 112.

Carl Moon of Zimmerman Post 560 gave a report on the Finance Committee's meeting at the Department of Minnesota Executive Committee meeting Oct. 26 the day before the Fall Conference in St. Cloud.

Moon filled in for the committee chairman, who was unable to

attend. Moon was the chairman the prior year.

He said the committee recommends a dues increase of \$3 for the Department of Minnesota beginning in the 2025

year. National American Legion HQ is raising its share of dues by

"We had a budget our commander said he wanted to balance. That made it a little difficult because we were over budget by about \$175,000," Moon said.

The increase in national-level dues was approved at the 104th National Convention in Charlotte. Any state-level dues increase would need to be approved at a department convention. The 105th Department Convention is July 11-13 in Willmar.

# E-tabs in the spotlight

### Lawmakers from St. Cloud area debate questionable way e-tab legislation passed

ST. CLOUD — The Allied Charities of Minnesota had the highest attendance for its annual convention in its history, at 830 people. The issue of electronic pulltabs was heard throughout the gathering.

The ACM Annual Convention was at the River's Edge Convention Center in St. Cloud on Nov. 16 and 17. ACM is an organization comprising licensed charitable gambling organizations from around the state.

There are 194 American Legion posts and Auxiliary units with gambling licenses, which makes Legion charities easily the largest participant in charitable gambling in Minnesota.

For a town hall forum on e-tabs, Sam Krueger, registered lobbyist and executive director for the Electronic Gaming Group, recounted the 2023 legislative game called "Jack O'Tantrum."



session and how the e-tab language skipped the committees.

"In order to get a fair shake at the Legislature, you got to go through the committee process," he said. "Finally, around mid-April, we were told something is coming and there is nothing you can do about it."

All session long, the e-tab issue discussed was the open-all button. Charities showed paper pulltabs can be opened at once by hand and not just three at a time, so e-tabs are similar.

When the tax omnibus bill came out of a conference committee, there were six hours left in the session before adjournment, and this bill had new language that went beyond merely the open-all feature, Krueger



## Minnesota Legionnaire debuts website at legionnaire.org

### Frequency of paper issue to drop to 9 a year

ST. PAUL — First, the good news: The Minnesota Legionnaire has a new website at legionnaire.org. Content will update 24/7 and be shareable across social media platforms.

Now, the bad news: The Minnesota Legionnaire print edition will reduce in frequency to nine issues a year instead

"The postage costs are hurting," said Editor Tim Engstrom. "About five years ago, it cost around \$8,000 or \$9,000

per issue to send out the Legionnaire to Legionnaire's postage costs for last all Minnesota Legionnaires. Now, even though there are fewer members, and we have the lowest possible nonprofit rate available, it is \$15,000 to \$17,000. There's nothing we can do.'

The Minnesota Department of Veterans Affairs, near the end of last year, awarded a Support Our Troops License Plate Grant to help the Legionnaire offset rising postage costs for one year and to aid with the cost developing a new website. Until the grant could be worked out, Bayport Post 491 made a generous donation that covered the

December's issue.

"We would be on life support without the grant and Bayport. The idea with this transition is that, on one hand, we have to reduce engagement in print, but, on the other, we can increase engagement online," Engstrom said. "And, besides, this will help us to reach younger veterans who prefer to consume media online."

The Legionnaire is a separate nonprofit from the American Legion Department of Minnesota. The Board of

Going forward, the print edition will come out every six weeks, for a total of nine per year.

The new website, however, will have fresh content daily. Want to see photos from the Fall Conference in St. Cloud? They are there. It has Taps, Listening Post, Mail Call, all the same content but as a website. St. Paul Media developed the website.

"They did a fantastic job," Engstrom said.

He said it was surprising that the National American Legion Headquarters didn't already own legionnaire.org, since its main site is legion.org and its members are called Legionnaires. He noticed it was available in November 2022 and quickly scooped it up.

The Board of Publications is suggesting members pay a \$35 voluntary subscription to help offset the rising costs so that the Legionnaire doesn't drop down again to six times a year.

"Even if a quarter of our





# 'E-tabs are the future of gaming'

said. The language removed free plays and bonus games starting in January 2025, and it gave a smidgeon of the tax relief the charities had asked for. The top tax level, at 36 percent, became 33.5 percent, starting July 2023.

"And that is the language we are stuck with today," Krueger said

There was a lie perpetuated during the 2023 session — politicians saying the Minnesota Court of Appeals wanted the Legislature to fix the law regarding the 2012 e-tab agreement with the tribes. Krueger said it was never the case. The courts only ruled that the Gambling Control Board improperly communicated a rule via email.

"It certainly didn't say the Legislature had to do something," Krueger said.

At the forum, state Rep. Bernie Perryman of St. Augusta said she could not properly represent her district because there was no time.

"There's nothing illegal about it. It's just icky," she said.

State Rep. Dan Wolgamott of St. Cloud said it was the most frustrating thing he has seen in his five years at the Legislature. He noted the next session begins Feb. 12 and it would be good to adjust the law before charities are impacted in 2025.

"We can't take legal action, but we can take legislative action," he said.

State Sen. Aric Putnam of St. Cloud sits on the Senate Taxes Committee. He said the matter was more than tribes and charities. He said manufacturers, providers and the Gambling Control Board are factors, too.

He said the open-all feature was not supposed to be part of e-tabs. Krueger corrected the senator and said the very first games approved by the state had open-all feature, as well as bonus games and free plays.

"No one complained until these games took off," Krueger

Putnam added that lawmakers were left with little time and said stuffing the language into an omnibus bill means he would have had to vote against valuable things like tax relief on Social Security income.

Perryman countered, "It should have been pulled out. It should have been a stand-alone. Why couldn't we have done that for all Minnesotans?"

Wolgamott went against his party last spring and voted against scaling back e-tabs. He said he favored sending the language back to the conference committee.

"There are times you need to stand up and buck your party," said Keith Franke, a former state representative from St. Paul Park and executive director of Protect Our Charities. "Do what's right for Minnesota and remove politics."

ACM Executive Director Rachel Jenner said the main concern of charities across the state is losses in revenue. She fears the games, after January 2025, will be less entertaining and players will drop. Lacking features limits the ability to evolve the games as software updates and improves.

"E-tabs are the future of gaming in Minnesota," she said.

Perryman said it was irresponsible of lawmakers to pass the e-tab language without a fiscal note. Vetting laws is part of the duty of elected officials, she said.

Franke shared some figures estimating 20 percent losses.

"I personally feel it's going to be a lot worse than that. People are going to be mad."

#### **Charitable gambling stats**

Jenner, citing recently released figures from the Minnesota Gambling Control Board, said charitable gambling in Minnesota in the 12 months ending June 30 had \$4,572,210,494 in gross receipts. Gross receipts are customers paying cash to play the games.

There were \$3,907,332,817 in prizes paid to those customers.

That left \$664,877,676 in net receipts. Net receipts get turned into two kinds of expenditures by each organization: allowable expenses and lawful purposes.

Allowable expenses are costs related to the conduct of gambling: wages, purchasing games, rent, license scanners, attending the convention. Lawful purposes are charitable donations, program expenditures, regulatory fees and state taxes.

There were \$335,195,312 in allowable expenses. There were \$330,364,035 in lawful purpose expenditures (LPE for short). Do the math and you see \$665,559,347 in total expenditures, which is more than the net receipts. That just means \$681,671 in retained funds from the prior year were spent down.

Of the LPE, \$193,129,939 went to state taxes and \$137,234,097 went to charitable contributions, nonprofit program costs and regulatory fees. It's easy to notice that more goes to the state than to the many good causes around Minnesota.

Overall, charitable gambling in Minnesota went up 6.4 percent over the prior fiscal year.

### **New GCB portal**

Gambling Control Board Director Tim Mahoney said his staff was asked more questions than anyone could recall, and they were happy to provide

### **Legislative stance for 2024**

There is plenty of debate over what happened in 2023, but what are nonprofit organizations asking from the 2024 Legislature?

Here it is

• Provide meaningful tax relief. Last session, the lawmakers granted tax relief bringing the top-tier from 36 percent to 33.5 percent, a slim reduction. Charities want that level to be 25 percent but would accept 30. The corporate income tax rate in Minnesota is 9.8 percent. Why are charities being taxed so harshly in comparison? The funds charities raise largely go back into their local economies and the good causes they donate to provide a valuable safety net for the disadvantaged.

• Broaden the tax structure. Right now, once an organization reaches \$157,000 in combined net receipts for their fiscal year, they already are at the top tier for monthly taxes. ACM and other organizations want to modernize the tier structure for the current economy. This, too, would provide some measure of tax relief. The other tiers presently are 25 percent for over \$122,500 accumulated, 17 percent for over \$87,500 accumulated and 8 percent for starting off.

• Reinstate bonus games and free plays. Bonus games and free plays do not mimic slot machines in any way, and courts have ruled on this. What determines slot machines are variable prize structures, jackpots and unlimited bets — not bonus games or free plays. Besides, what's the difference between awarding a free play on a \$5 game or a \$5 prize? Nothing. The tribes only asked for removal of the open-all feature last session. Inserting additional language was a punitive action by some anti-charity lawmakers.

• Push back the enactment date by one year. This e-tab industry took 10 years to build, and the Legislature asked the gaming industry to revamp it in one year. That's not possible. What if by January 2025 there have only been four games approved? What if there are 25 games approved but they are all dull? Either way, gaming revenue crashes. There remains a lot to figure out in the next year. Move enactment to January 2026

"Our goal is to make you successful," Mahoney said.

Mahoney spoke about a new computer portal coming out soon. His comments reflected what was printed in the GCB's Gaming News, that testing is ongoing: "Since each enhancement will need to be completed before the next one can be started to see what effects it has, we do not have an anticipated launch

date."
Mahoney said he called on his agency to mail out the quarterly publication called the Gaming News in an effort to have more

He hopes to continue mailing it. He also spoke about an in-

rease in staffing, citing how the agency has maintained staffing levels for a long time.

Classes at the ACM gathering were on the topics of security, theft prevention, paper pulltabs, bingo, e-tabs, audits, marketing, legal matters, software, inventory, problem gambling, oversight of sellers, new ideas, best practices — and staying out of the Gaming News.

Minnesota receives a guaranteed royalty of \$25,000 from PCI to assist it in its mission of serving veterans.

The Minnesota American Legion lost a great treasure with the passing of Bill Goede. He never stopped working for the betterment of this veterans organization.

I was around for a lot of Bill's career with the Legion. He was the first membership director after I became editor of the Legionnaire, and we got to know each other better on the first of my many National Commander's Tours, where the membership director is in charge.

For me, though the years, he was always someone you could approach with a new idea or even a bad idea. He would sort them out. He always had a vision for how the Legion could be a better organization, and he was willing to lend his support to new ways of doing things. More than that, he would invest his own time and talent into a project that was good for veterans.

Just one example. In about the year 2000, someone had an idea to take the stories of veterans that had appeared in the Legionnaire and put them

in a book. Not only would the stories be preserved more permanently, but the funds from the sale of the book could be used to support the construction of the new World War II Memorial at the State Capitol. In the end, "War Stories" sold over 5,000 copies and over \$70,000 was raised for the memorial. The book is sold out, but "War Stories Vol. II" and "War Stories Vol. III" remain available

for purchase. I can attest that the idea of the book would have remained an idea except for Bill Goede. He made it happen. He provided the leadership and the determination to see it through.

Nearly every one of us who knew Bill through the years can tell a story like that. He lived and breathed the Legion. He exemplified the axiom of Past National Commander Dan Ludwig, who was a mentor to both of us: "Tell the truth. Take the high road. Remember the cause.'

As the Legion slowly turns toward younger leadership, those ascending leaders can have no better example than Bill Goede.



**Fall Conference kept Legion fires burning**

The Finance Committee voted in favor of a one-time withdrawal from the department stocks account of \$160,000, and anything unused at the end of the fiscal year will be put back in. In the meantime, it will be in a money market account drawing 5 percent interest.

It still left a shortfall of \$4,850.

Moon noted 64 percent of the department budget is paid by dues. At the National HQ, dues cover about 44 percent.

"The elephant in the room is membership," he said. "We talk membership every year, and it doesn't go anywhere. So you need to get out to your post, to your districts and talk membership and encourage them to get more members. With everything going on right now in the Middle East, I think we can rally around the flag and patriotism."

Moon said the stocks account as of Sept. 30 had \$928,940, with a projected income of \$21,793. The fixed account, with the extra \$160,000 in it, was at \$2,054,088, with a projected gain of \$67,686.

#### Legionville

Moon is the president of the Legionville Board of Directors and offered a report on the camp.

It had 213 campers all summer long and can accommodate as much as 144 every week, he said. That and a decrease in donations left the camp \$33,706 over budget.

Anthony Koop and 3rd District Commander Rod Reifstick have Legionville as their projects, which should help with fundraising.

The camp is known for its crossing-guard safety program, but it also offers bus safety, water safety, CPR and other forms of safety. He said the camp is considering gun safety, not in the sense of shooting guns but what to do if a child encounters a gun.

"We want to stress to schools even if you do not have a crossing program to the school, how many kids ride school buses. That's going to be the key," he said. "A lot of schools come to our camp manager, Adam Felton, and say we didn't know we can get sponsorship from a Legion post."

He said he wants to begin having fire departments teach fire safety, like stop, drop and roll. He called on others to inform posts and schools statewide.

The board voted to offer six weeks of camp in 2024 instead of seven. Registration begins in February.

The next Board of Directors meeting is March 22 at Legionville. There will be discussion on revised Constitution and By-Laws.

### **Foundation**


The Minnesota American Legion Foundation, annually, shares the revenue from its investments with several programs under its charge.

- \$500 to Junior Shooting Sports. As of Sept. 30, the foundation's net worth is \$1,926,283. Of that, \$256,211 is in cash and \$1,680,052 is in investments.

The foundation, Ricker said, is putting \$5,000 in each of two new veterans homes, in Bemidji and Montevideo, as well as \$5,000 for the new state cemetery in Redwood Falls.

Department Service Officer Ray Kane spoke on the Minnesota Veterans Assistance Fund, which is designated

'We are working on different programs to make sure that we use Fund 85 effectively and it's our last resort,"

He noted multiple cases in the past quarter where he and the assistant department service officer, Janet Lorenzo, directed veterans to MACV to solve their housing issues. They also guided them to the state for use of the State Soldier's Assistance Program grants. They helped veterans receive assistance from their county veterans service officers or Beyond the Yellow Ribbon or food shelves.

Kane told the story of rescuing a veteran from Scandia from his housing problem with temporary assistance Marine Lake. He said Lorenzo got him

• \$3,000 to Rehab Veterans Outdoors into temporary housing for 30 days.

He thanked posts for providing money, noting Hastings Post 47 donates \$1,000 a month.

Kane and Lorenzo encourage veterans seeking help to go through a website called Unite US at uniteus. com. He said the site tracks how often the person seeking help comes back for additional needs from other nonprofits, and he said the veterans the assistance fund helps are returning for help more than two or three as less often than ones being helped by most other organizations.

"That's a reduction because we work with them to make sure they don't have to come back to us, making sure that their needs are met 100 percent before they walk out that door," he said.

#### Legislation

The Legislative Committee put together its 2024 Legislative Priorities this fall. The DEC approved the priorities at the Oct. 26 meeting. Readers can find them in this issue, and they can find them in the "Legislative" tab of the department website, mnlegion.org.

#### **Police officers**

Department Judge Advocate Greg Colby brought up a case where a meth user shot four or five deputies who were serving a warrant. Fortunately, no deputies died.

He said he is a retired criminal defender who usually helped clients win cases against police officers.

"This is about criminal justice. I don't know what the answer is, but I do know that we have got to stand up and say cops are not targets of opportunity," Colby said. "We need good police officers, and the vast majority of them are."

# Windom installs new veterans memorial at Lommen Park

Windom City Councilman Marv Grunig, a retired manager with Windom Electric Utility Mgr., spearheaded an effort to construct a veterans memorial at Lommen Park on Highway 60/71 in his community.

The idea for the memorial came out of a strategic planning session held by the City Council early in 2020, where, when Grunig mentioned his thoughts about a memorial, city officials supported the idea. Grunig went forward with the effort to develop the vision further.

With support from the City Council and Windom American Legion Post 206 members, and permission from the Park and Recreation Department to construct the memorial in Lommen Park, the effort then turned to fundraising.

Being Grunig is on the City Council, the fundraising had to be done by a private entity and with the newly created Windom Area Foundation as the "bucket" to collect tax-deductible donations, a matching fund drive by Bank Midwest, lots of advertising by the local newspaper (the

Windom City Councilman Marv Grunig, a Cottonwood County Citizen), funds came in tired manager with Windom Electric Utility quite fast.

Having traveled though the state looking at different memorials, Grunig then created a model of a possible memorial for Windom, just to give people an idea of what it might look like.

The model was met with approval, so a print was developed by DGR Engineering from Rock Rapids, Iowa, for concrete contractors to bid on. Local funeral director Joel Lacanne engaged his vender in St. Cloud (Sunburst Memorials) to develop monument options. A vender for the flagpoles and flags was chosen from Gaylord (Flagpole Solutions), and the project was coming together.

With a great spirit of giving, Windom area citizens and businesses stepped up with donations. With discounts from venders like Cemstone Concrete, the funding goal was reached.

The concrete was poured and jet-black monuments held by limestock blocks were installed late last summer.




