## Trooper says, 'Crash into me'

#### Legion to honor quick-thinking officer of the law

MOORHEAD — Have you ever seen the Keanu Reeves movie "Speed"? This story is like that.

Zachary Gruver, a Minnesota state trooper out of the Moorhead office, is the American Legion Department of Minnesota Outstanding Law Enforcement Officer for 2025. His actions saved a young man's life.

Sam Dutcher was driving a 2022 Honda Pilot near Harwood, N.D., on Sept. 17, 2024, when it began accelerating out of control.

According to multiple news reports, the 18-year-old tried pressing on the brake pedal. He tried undoing the accelerator. Nothing he did would get the midsize SUV to stop or slow down. Dutcher called his mother. She was afraid her son was going to die and called 911.

Dispatchers reached Dutcher, and they discussed other options, like **Continued on Page 7** 

## From radio to food

Tom Lyons is known for Minn. Military Radio, but now he is feeding veterans

#### **By Tim Engstrom**

OLDEN VALLEY — Vietrnam veteran Tom Lyons is best known in the Minnesota veterans community as the founder and past host of Minnesota Military Radio. Nowadays, he's involved in a new cause — feeding veterans.

"It bothers me that there are veterans going to bed at night hungry," he said. "I've reached the conclusion I have to give back.'

In January 2024, studies by the U.S. Department of Veterans Affairs found that 11 percent of veterans are "food insecure," meaning they lack reliable access to food, whether it is money, physical limitations, family looking after them or other resources.

The VA decided to OK the use of its system of medical centers to provide food to veterans. The Minneapolis VA was able to use non-appropriated federal funds plus donations from Second Harvest, DAV Foundation and others to get a food pantry rolling in April 2024.

Minneapolis VA Director Pat Kelly doesn't want the program to rely on federal, state or local grants. He met

with Lyons, DAV of Minnesota Adjutant Butch Whitehead and Minneapo-Rachel Hammer, to come up with ideas.

Whitehead and Lyons told Kelly that they would form a 501(c)(3) nonprofit organization to fund the food pantry. "We'll be your fundraising arm,"

Lyons said.

We wanted to launch a separate lis VA Director of Civic Engagement nonprofit so that we could make sure it had the flexibility to help all Minnesota veterans, not just in the metro," Whitehead said.

Lyons received the IRS letter by the end of 2024. The nonprofit is called

the Minnesota Veterans Food Pantry. Its website is mnvp.org.

Lyons made the first donation on Jan. 2, 2025. Then he got some Vietnam veteran buddies to pony up. He also set up his account to automatically give. Now, he wants the readers of The Minnesota **Continued on Page 8**

He was the subject of the book "Damn Lucky" by Kevin Maurer.

Luckadoo spoke at the April 22

# Bravo Zulu House opens veteran-specific sober home

#### Critical gap in care for PTSD is recognized

WINNEBAGO — Instead of just thanking veterans for their service, Bravo Zulu House sends the message of welcoming them home to a place where they can address challenges.

During the grand opening of the first all-military sober living facility dedicated specifically to serving veterans with PTSD, veteran Mike Gilligan told the audience the phrase "Thank you for your service" is used too often and sometimes abused when talking to veterans.

"There's two words instead of the five words, 'Thank you for your service' that will light a veteran's eyes, especially the ones that are clouded with PTSD," Gilligan said. "Those words are 'Welcome home.""

Tucked away in Winnebago and surrounded by fields, the facility aims to address the mental health challenges contributing to veteran suicide. Its grand opening was celebrated on Wednesday and will be checking veterans in by mid-June.

As a member of the board of directors, Tim Murray spearheaded the initiative after recognizing a critical gap in veteran care. The facility represents a holistic approach to addressing the challenges faced by veterans returning from service. Murray is also a board member and CEO of Trinity Sober Homes, a St. Paul nonprofit providing shelter and recovery to men who struggle with alcoholism.

leader of this small but mighty organization dedicated to the war on PTSD," he said. and trauma-informed care, structured fitness programs, canine therapy and hydroponic

Ret. Gen. Joseph Votel, a board member of the project, said the need for such specialized support is urgent and noted that veterans with substance abuse disorders face significantly higher suicide rates compared to the general population.

Ground broke on the house in September 2024 and the facility is built around an integrated care model intended to support sobriety, physical and mental health and spiritual development. At capacity, the home has 12 beds. Services include counseling and trauma-informed care, structured fitness programs, canine therapy and hydroponic gardening. On the property sits not only the house with 12 separate bedrooms, but also a warehouse that will eventually house the gym and the hydroponic garden.

Supported by a coalition of partners, including the Mayo Clinic Health System and Housing First Minnesota, the house integrated behavioral health services tailored specifically to veterans' needs. putting the vehicle in neutral. Nothing worked.

Clay County Deputy Zach Johnson was speaking to Dutcher when the Pilot picked up even more speed. The computer system had taken over. They tried stop sticks to pop his tires, and that didn't work.

With police cars following him, Dutcher would cross through busy intersections and enter Minnesota on Clay County Road 26 heading east. News reports say he was reaching 113 mph as he sped toward Hitterdal. The problem was that about 3 miles east of Hitterdal, the county road ends and gravel begins. After 1 more mile, the gravel turns north, and going straight at high speed was no longer an option.

Trooper Gruver took action before the pavement ran out. He sped past Dutcher at 130 mph while Deputy Johnson spoke with Dutcher on the phone. Johnson told Gruver to crash into the back of the State Patrol car.

# Minn. Legion charters new post in a prison

#### **By Steve Brooks**

OOSELAKE-Minnesota Post 1918 in Moose Lake Correctional Facility just the second to charter in one of the state's prisons.

Because a Minnesota Legionnaire is a strong believer in second chances, the American Legion department now has its second post based inside a prison.

American Legion Post 1918 recently had its chartering ceremony inside of Minnesota Correctional Facility-Moose Lake, which consists of two separate facilities. The post was chartered in the medium-security facility there that houses roughly 1,000 men.

The idea of chartering the post came from Legionnaire and Sons of The American Legion member Glenn Mueller, whose membership is through American Legion Post 90 in Lewiston, Minn., but who also is serving as membership chairman for Post 1918. Mueller has held multiple positions at the post, district and department level and took a job at the prison after his wife retired from the Mayo Clinic and they moved into the area.

Following the graduation ceremony after Mueller completed his training to become a plant maintenance engineer at Moose Lake, he said he stood up to salute the U.S. flag, which drew the attention of one of the assistant wardens.

"I was asked, 'Are you a veteran?' and I said, 'Yes, I am.

I'm very proud of my service," Mueller said. "I was asked, 'Will you work with the veterans here?' I said, 'Sure, I will, in a heartbeat.' I met with them a month later, and I met with them a second time and asked, Would anybody be interested in starting an American Legion post?' I looked it up and saw a lot of other states are doing it,

so why don't we try it?" Mueller said starting the post is an attempt to give its members a leg up when they leave prison. "Most of them are going to be (out) in the next five to seven years. When they get out, I don't want them to be homeless," he said. "I want to be able to put them in a post, whether it's in Edina, Mankato, wherever they're going. I want to be able to put them in a post so they can help that post out, and that post can help them.

'I want them to have a place in society when they get out. Maybe they need some benefits when they get out. I'm just proud to be able to step up and help them out where I can."

Mueller began passing out membership applications, and within a month 22 of them had been filled out. He went through them to ensure all of the applicants met eligibility requirements. He also passed out pamphlets on various American Legion programs to get the veterans some insight into the organization.

Mueller sent the charter application into department headdelay in the process. But his members.

persistence paid off when the department approved the charter and then National HQ provided the final approval.

In mid-April, the post received its charter during a ceremony at the prison. There were a total of 35 charter members, including Moose Lake Assistant Warden Brian Collins.

'All of you who rose your hand and said the oath and swore to defend the Constitution, wore the uniform, your service matters and it continues to matter today," Collins said during the charter ceremony. "I refuse to accept that people are judged by the worse day that they have had."

Mueller has a similar view of the members of Post 1918. 'We've all done our share of bad things. Some people a lot worse than others," he said. "And they got caught. And you pay the price. Everyone deserves a second chance.

"I'm a Legionnaire that believes if I can help out another Legionnaire, I don't care about being paid back. I want to help that individual have a better life all the way around.'

Minnesota had a post chartered in 1998 for the prison in Appleton, Minnesota. The prison was the privately held Prairie Correctional Facility, so the post was Prairie Post 1998. The prison closed in 2010 following the expansion of stateowned prisons in Faribault and Moose Lake.

Legionnaire to visit the website and contribute, too. The food pantry takes place from 10 a.m. to 2 p.m. (or out

of food) on the third Tuesday of each month in the auditorium of the Minneapolis VA Medical Center. No ID is needed. All a veteran has to do is walk in.

Kelly said there are plans to expand it to VA clinics in the Twin Ports and Chippewa Falls before the year ends.

"Tom is an unbelievable partner and advocate and sponsor," Kelly said. "He can support as much as we can do. He's made this his next mission, and he's really gone after it."

Kelly said the pantry serves an average of 230 veterans each time.

The law firm specialized in personal injury but also handled mergers and acquisitions. Lyons worked there for 10 years and became adept in the field.

"I brought many assets to the table. I did the spreadsheets and learned mergers and acquisitions the hard way," he said.

By 1985, the law firm planned to send Lyons to Wyoming, so he changed course and decided to set up his own firm. This became Faelon Partners Ltd., which is a business brokerage firm offering representation for mergers, estate and financial planning and acquisitions. Primarily, the firm helps clients buy or sell businesses.

## Luckadoo: 'We don't know what our current generation would do.'

He said he has made it his mission in the time he has left to recognize civilians who served their country "to come out of the homes and into the factories to out-produce the world."

Asked whether today's generations would answer the call his generation did, he said, "We don't know what our current generation would do, and we didn't know."

In the 100th, he had four enemies: fear, fighters, flak and freezing cold.

"If you survived as we did, you were just damn lucky,' Luckadoo said. "You see friends go down in flames all around you, and you think, 'How in the world did I ever find myself in this spot?' You grow up really fast.

Maurer was there, too, and he gave a presentation on Luckadoo's story.


Luckadoo was born in March 1922 and raised in Chattanooga, Tenn. He and his childhood classmate, Leroy Sullivan, wanted to fly. Sully joined the Royal Canadian Air Force. Luckadoo's mom wasn't having it. He ended up joining the U.S. Army Air Forces after the Pearl Harbor attack.

Eventually, the two old pals met up in England. Sully flew Spitfires. Lucky flew B-17s.

Sully said, "You are nothing but a truck driver."

Lucky replied, "This war needs truck drivers, too."

Maurer retold the history of Germans having air superiority over Europe. American military leaders, relying on the Norden bombsight, felt they could in the war with bombs dropped at 25,000 feet from airplanes in tactical formations during the day. The British RAF opposed this and conducted their raids at night at low altitudes. Even with the bombsights, Americans still were unsure where the bombs landed. "We were guinea pigs sent out to prove this theory," Luckadoo said. "When you drop bombs five miles up, it goes through all kinds of air currents before it hits the ground. You are lucky if you hit the target."



finished his tour in October 1943. The average life expectancy for B-17 crews in the Bloody 100th was seven missions.

The 100th Bomb Group was portrayed in the Apple TV miniseries "Masters of the Air." It is meant to be a companion to "Band of Brothers" and "The Pacific."

The tale of Sullivan is noteworthy. His father had died in May 1921 of blood poisoning before he was born. That meant he was his mother's only child. As a single mother, she raised him from birth and had been against him going into the military, eventually relenting to his feverish desire.

Sully was flying a Hawker Typhoon on Nov. 7, 1943, when the engine busted right after takeoff at an airfield in Woodbridge, Suffolk. He managed to pass over some trees and keep it aloft 600-800 yards before the aircraft spun into the ground.

in the 92nd Bomb Group. His B-17, named "Pot O' Gold," was shot down by German fighters on Feb. 22, 1944, near Thisted, Denmark, and he managed to get out, depart the plane and deploy his parachute. All 10 men bailed out, and all survived except the pilot, who drowned in a lake.

The men were captured, interrogated and beaten. Schrenk spent 15 months as a POW. The Germans moved him from stalag to stalag as the Russians advanced. Finally, they had no place to put them so they marched and marched to evade the Allies, in what became known as the German Death March. Eighty-six days and 800 miles later, the English Army liberated them.

In April 2012, Schrenk met the German pilot, Hans Hermann Muller, who had shot down his aircraft but didn't fire again after seeing them bail out.

"I wanted to thank him for not finishing us off," he said. • Bob Holmstrom, 99,

Maplewood. A pilot, Holmstrom flew on 30 suicide missions over Germany, at times almost to Russia and Switzerland, as part of a clandestine group called the Carpetbaggers. They never dropped a bomb. Instead, they dropped supplies to 350,000 people in the underground resistance. They would fly 500 feet high or lower to evade radar and just above stalling speed at 120 mph so they could read ground signals and deploy parachutes. Sometimes, they would drop spies, too, but they weren't allowed to talk to them.





Title: Expanding the Presumptive Agent Orange Exposure Due to Soil Contamination on the Korean DMZ to August 31, 2001 (The Tappainer Act)

Author: Post 586 {Marissa LaCourt}

WHEREAS, the United States Department of Veterans Affairs (VA) recognizes that veterans who served in certain areas of the Republic of Vietnam during the Vietnam War are presumed to have been exposed to Agent Orange and other herbicides, which has led to various health problems; and

WHEREAS, Agent Orange was used extensively on the Korean Demilitarized Zone (DMZ) to clear vegetation and reduce concealment for enemy forces during the period of April 1, 1968, to August 31, 1971; and

WHEREAS, many veterans who served on the Korean DMZ during the above-mentioned period were exposed to Agent Orange and other toxic herbicides, but their service has been excluded from the VA's presumptive exposure list; and

WHEREAS, the VA has recognized soil contamination from Agent Orange on the Korean DMZ, and some veterans who served after 1971 are suffering from conditions associated with Agent Orange exposure, yet they remain ineligible for benefits due to the VA's limited presumptive service connection timeline; and

WHEREAS, there is growing evidence that soil contamination from Agent Orange remained in the DMZ area for many years



after the last known use of the herbicide, potentially affecting veterans who served beyond August 31, 1971; and

WHEREAS, veterans who served in the DMZ up to August 31, 2001, may have been unknowingly exposed to toxic herbicides due to residual contamination from Agent Orange, putting them at risk for the same health conditions as those veterans who served within the original presumptive period; and

WHEREAS, these veterans and their families deserve recognition, support, and access to appropriate medical care and benefits for the health effects caused by Agent Orange exposure; and

WHEREAS, the American Legion has long been a vocal advocate for fair treatment of all veterans, ensuring they receive the benefits and recognition they deserve for their service and sacrifices;

Now, therefore, be it resolved, that the American Legion urges the United States Congress and the Department of Veterans Affairs to expand the presumptive exposure for veterans who served on the Korean DMZ to include those who served until August 31, 2001, due to the ongoing risk of exposure to soil contamination from Agent Orange; and

Be it further RESOLVED, that the American Legion calls for appropriate funding and research to assess the impact of Agent Orange exposure on veterans who served in this region and to provide them with the medical care, benefits, and recognition they are entitled to under the law; and

Be it further RESOLVED this resolution was approved at Post 586 general membership meeting May 1, 2025 and this resolution is forwarded to the Department of Minnesota Third District convention scheduled for 17 May 2025; and

Be it further RESOLVED this resolution was approved at the Department of Minnesota Third District convention scheduled for 17 May 2025, and this resolution is forwarded to the Department of Minnesota convention 10-12 July 2025; and

Be it finally RESOLVED, this resolution upon approval at the Department of Minnesota convention is forwarded to The American Legion National convention 26-28 August 2025 for concurrent action.

The 106th Annual Convention of The American Legion, Department of Minnesota, is hereby called in conformity with provisions of the Department Constitution and By-Laws, and by action of the Department Executive Committee, sponsored by Willmar American Legion Post 167 and held at Willmar Conference Center in Willmar, Minnesota, July 10, 11, 12, 2025.

#### **PURPOSE OF CONVENTION**

The Convention is called for the purpose of electing officers for the ensuing year, amending the Constitution and By-Laws, and for the transaction of such other business as may be brought before it.

#### REPRESENTATION **AT CONVENTION**

The Department Convention shall be composed of delegates from each Post, members of the Department Executive Committee, the Department Chaplain,

Treasurer, Historian, and the District Adjutants, but only delegates from Posts shall be entitled to vote at such Convention, (Sec. 2, Article 5, Department Constitution). Each Post shall be entitled to two delegates and to one additional delegate for each hundred members or major fraction thereof, whose Department dues have been received by the Department Treasurer and whose District dues have been paid to their respective District officers, 30 days prior to the Convention for which they are chosen. The final voting strength of each Post shall be determined 30 days prior to the Convention. Each Post shall choose its own delegates, who shall be members in good standing of such Post. In addition, each Post may choose alternate delegates to serve in the absence of the principal delegate, (Sec. 3, Article Five, Department Constitution). Delegates or alternates must register in order to vote.

## **Rules for 106th Dept. of Minnesota Convention**

To the Post Commanders:

The Rules Committee submits the following proposed Rules for the Convention to be held in Willmar, Minnesota, July 10, 11 and 12, 2025:

- 1) With the following modifications, Robert's Rules of Order, revised, be adopted for this Convention.
- 2) (a) That the speech of any Delegate, recognized by the Commander, shall be limited to three (3) minutes and no more.

(b) Where a motion is made to table a resolution, the sponsor shall be entitled to speak to the Convention for three (3) minutes on the subject, and three (3) minutes rebuttal be granted to the maker of the motion to table before the motion is put.

3) That the Floor be permitted but once to any individual on any subject, except with the unanimous consent of the Convention.

4) (a) That all resolutions, with the exception of those prepared by Convention Committees, must be presented in writing signed by the author thereof, not later than 9:00 A.M. the first day of the Convention, to the Department Adjutant who shall refer them to the Resolutions Assignment Committee without debate. Each District Delegation Chairman or Secretary will meet with the Department Resolutions Assignment Committee at 9:00 A.M. of the first day of the Convention to be informed as to the resolutions assigned to each Convention Committee, then provide copies of those resolutions to the representatives they have appointed to said Convention Committee. The Resolutions Assignment Committee is responsible for receiving, registering and accounting for all resolutions forwarded to it by the Department Adjutant and all committee originated resolutions. (b) Resolutions containing matters of legislation shall be cleared by the Convention Legislative Committee.

(c) In the event a convention committee does not receive any resolution assigned to that committee, said committee has no requirement to meet. 5) On matters where voting has been by roll call vote, when the poll of any Post Delegation is demanded by the Delegate of any Post, the Secretary of the Convention shall poll the vote of that Delegation

by Delegates, without debate or discussion. 6) That on Roll Call, the Chair or Acting Chair of each Delegation on the Floor shall announce the vote of this Delegation. 7) No person, not duly accredited, shall participate directly or indirectly in debate on any subject before the Convention, but Past Department Commanders and members of the Department Executive Committee shall have the privilege of speaking from the Floor, but not of voting, except as Delegates. 8) That no Delegate be permitted on the Convention Floor unless certified by the Delegate's Post as Delegate or Alternate and that every Delegate or Alternate, to be duly accredited, must be registered.

for elections which shall be as follows:

- (a) The election of Department Officers, NEC positions, and the Member of the Board of Publications shall be by written ballot unless there is but one candidate or, in the case of election of Vice Commanders, there are but five candidates. (b) The election of candidates for other positions shall be by District as set forth in Rule 14 below. Candidates receiving the highest number of votes in one round of voting shall be elected to the positions.
- If there are more than five candidates for Vice Commander, those five receiving the highest number of votes shall be declared elected. Cumulative voting shall not be allowed.
- The printed ballot shall include the names of all candidates who have notified the Department Office of their candidacy at least 30 days prior to the first day of the Convention.
- For the election of Department Officers and NEC positions, the Tellers shall issue to the Delegation Chair of each registered Post the number of written ballots equal to the delegate strength of that Post. Said Chair shall sign for the ballots.
- Ballots shall be issued and the polls shall be open during the following times:

(a) Friday, for one hour after recess of the Convention, with a starting time to receive ballots no more than one hour after the Department Commander or his designated vice commander gavels the session of the convention into recess. A time less than an hour may be set by agreement between the Department Commander or his designee, the Department Adjutant, and the Department Judge Advocate.

(b) Saturday, from 8:00 A.M. until 8:30 A.M. No ballots shall be counted before Saturday morning.

No ballots shall leave the polling place. The District Commander of each District shall ap-

point a Teller. Tellers shall elect among themselves two Tellers from the Districts which have no candidate for Commander. These two Tellers, and the Judge Advocate, shall tabulate and total the election results. The result of each contest shall be confidential and shall be placed in a separate envelope and delivered to the Commander.

If there is a written ballot contest which has not resulted in a majority vote (except for Vice Commanders), the Commander will be informed im- Committees:



14) When the convention has adopted a Motion to suspend the rules and vote on a matter by District, each District may vote its entire voting strength. If the matter is the election of individuals for any open positions (such as Department Delegate at-Large), each District may vote its voting strength times the number of open positions, but shall not vote more than its voting strength for any one individual. The call for District votes shall be in ascending order starting with the District whose number matches the last digit of the year of the Convention.

- 15) In the event more than two candidates are nominated for any office, the balloting shall continue until one candidate shall have received a majority of the votes cast. In elections where there are more than two candidates, the candidate receiving the fewest votes in each round of voting shall be eliminated
- 16) No personalities or partisan politics shall be discussed or indulged in on the Convention Floor, and the Department Commander shall prohibit such indulgences.
- 17) (a) Rules Committee approves the following list of Convention Committees to be chosen at this Convention, each District to choose one representative on each Committee:
  - Americanism National Security/Foreign Relations
  - Children & Youth
  - Public Relations
  - Constitution-By-Laws
  - Recreation-Sports Employment

  - Rehabilitation
  - Legislative Resolutions
  - Membership
  - Safety-School Patrol
  - (b) The following Department Standing Committees are approved as Convention

Historian Sergeant-at-Arms

Member of Publication Board, for three-year term

Delegates-at-Large to the National Convention Five Alternates-at-Large to the National Convention

National Executive Committeeman and Alternate National Executive Committeeman (when appropriate)

- 20) The Committee Chairman shall inform the Department Commander when the report is ready to be presented, and the Department Commander shall recognize it as an order of business. The committees reporting action on Resolutions must read all approved Resolutions. It is sufficient to report all rejected Resolutions by number, unless requested by a Delegate to set a Resolution aside for separate consideration.
- 21) All printed reports, which shall have been handed to the Convention Committees, shall be referred to the proper Convention Committee for action.
- 22) No Band, Drum Corps or other musical organization shall be permitted in the Convention Hall without the invitation of the Department Commander.
- 23) (a) Any Guests who are not on the official program as speakers shall be introduced by the Department Commander only, and shall be limited to an address of not more than three (3) minutes. (b) The Commander is to adhere as nearly as possible to the printed program so that guests, and others to be honored, are presented without undue delay.
- 24) No elective political office holder shall be permitted to speak during the Convention except the Chief Executive of the State of Minnesota, and the Chief Executive of the Convention City, or such persons as are on the official printed and published program.
- 25) All major speeches shall be limited to fifteen (15) minutes and all others not to exceed five (5) minutes.
- 26) No intoxicating liquors shall be sold or dispensed in the building of the Convention meeting, except as authorized by the Convention Corporation.
- 27) The Roll Call of Posts shall be called in numerical sequence in accordance with Post numbers assigned, including the city or town, beginning

- 9) That the published program be approved by this Convention.
- 10) No person or Delegate shall act by proxy for any Post. No Post shall vote unless at least one registered and accredited Delegate or Alternate be present on the Convention Floor.
- 11) The voting shall be by acclamation, except when a Roll Call is demanded by the Chair or Acting Chair of at least three Delegations; and except

Tabulation and reporting shall be in accordance with these Rules. Results of the vote count shall be reported to the Convention. All ballots and results shall be destroyed immediately following the close of the Convention, unless there is a motion to preserve. 12) Nominations for Department Officers and NEC positions shall be held on the afternoon of Friday of the Convention. Nominations shall be made from the Floor on Roll Call by Districts, in ascending order starting with the District whose number matches the last digit of the year of the Convention; each District may present as many candidates as it chooses. Thereafter, nominations may be made from the Floor.

13) Nominating speeches for Department Officers shall be limited to five (5) minutes. There will be no seconding speeches allowed for any candidates.



## Listening Post He has given 25 gallons in 65 years

WOOD LAKE - Lifelong blood donor Larry Peterson, of Wood Lake, marks milestone in his lifesaving mission.

Three times a year, Larry Peterson makes it a practice to save lives.

This time, his life-saving practice made him something of a celebrity.

Peterson donated the unit of blood at the Willmar Community Center on Tuesday that brought him to the 25-gallon mark as a lifetime blood donor.

"It's really something, I can tell you that," a smiling Peterson said shortly after the unit was collected.

He had intended to reach the milestone one week earlier in Montevideo, where it all began 65 years ago.

The Red Cross had a large cake and a certificate to honor him on the achievement, but he wasn't able to donate that day.

Peterson, 84, donated his first unit of blood on Dec. 7, 1960, at the age of 19.

"My dad took me along the first time in Montevideo, at the old National Guard Armory," Peterson told the West Central Tribune. "He said, you come along and donate your blood."

His father, Ray, had been a longtime donor, said Peterson. At that first visit, Peterson learned something that has made him a valuable donor for the Red Cross ever since. He learned that his blood type is O negative, which makes him a universal donor. His blood can be transfused into virtually any recipient regardless of their blood type.

There's no question that donated blood has a big impact on the lives of recipients, whether it is by helping them through a surgery or, in many cases, saving their lives after a traumatic injury.

Peterson believes he has possible saved hundreds of lives through the years.

Years ago, there have been occasions when Peterson was called from his work as a machinist at a hydraulics manufacturing plant in Granite Falls to the local hospital to donate blood directly to individuals facing an emergency need.

Lying side by side, blood flowed from his arm directly to the patient. He still gets emotional talking about the experiences, and he has plenty of reason to be proud. In each of those cases, he was told the recipient survived.

On top of it all, Peterson is what the Red Cross terms a "power red" donor. He typically donates two units each visit. A special machine is used to return plasma and platelets to the donor to allow a safe donation of two units, according to the Red Cross. no pun intended. Along with a career as a machinist for more than 43 years, he donated his time to serve as a volunteer firefighter in Wood Lake for 26 of those years.

After he donated blood for the first time with his father, Peterson was drafted into the U.S. Army. He donated blood while in the military and has continued ever since.

Larry and his spouse, JoAnn, will celebrate their 60th anniversary in April. She is a coordinator volunteer for Red Cross blood drives in Wood Lake. They are the parents to four adult children, a daughter and three sons. Two of their sons and two grandsons also have type 0 blood.

Through the years, Peterson kept all of the cards and letters he received from the Red Cross as he reached donor milestones. Letters informed him that his blood was sent to save lives at hospitals all over the country, from California to Connecticut and to places closer to home, including Willmar and St. Paul.


The Red Cross does not have statistics on milestones like Peterson's according to Lynette Nyman, regional communications manager with the Red Cross. But she noted that milestones like his are definitely worth noting and celebrating.

He schedules his donations at locations within an hour's drive of his home, and Red Cross workers who take his blood know him well. "They love me, each place I go," he said laughing. They know who is coming.

Know this: He plans to continue donating, I'll keep going as long as I can." He said after reaching his 25-gallon milestone.


Reflecting on the past two forming years of being a district commander and doing the job with PTSD has been a profound experience. It is a testament to the strength of character and resilience that can emerge from the most challenging circumstances.

As a commander, the responsibility to lead, inspire and care for the members of the American Legion is paramount. Despite the personal battles with PTSD, the commitment to elevating the district to first place and the unwavering care for its members has been the driving force behind this journey.

Post-traumatic stress disorder is a mental health condition triggered by experiencing or witnessing a traumatic event. Symptoms can include flashbacks, nightmares, severe anxiety and uncontrollable thoughts about the event.

For veterans, PTSD is a lingering shadow of their service, affecting their daily lives and mental well-being. The journey of managing PTSD while fulfilling the duties of a district commander has been an intricate balance of personal healing and professional dedication.

Leading with PTSD comes with unique challenges. The weight of responsibility can sometimes exacerbate the symptoms, making it difficult to navigate the complexities of command. However, it is the same experience that fosters a profound sense of empathy and understanding towards fellow members who might be battling their own demons. This shared experience creates a bond that is both unspoken and powerful, power. Position isn't power.





Zimmerman is a Purple Heart recipient and advisory board chair. He said many lives have been lost unnecessarily because there wasn't proper support.

Bravo Zulu originates from a naval signal meaning "well done." The project emerged from grassroots community efforts, with funding primarily sourced from local businesses, individual donors and veteran support, who raised \$1.3 million collectively. The facility represents a model that could potentially be replicated across the state and nation, Votel said.

Murray said the house stands as a testament to community-driven solutions in veteran care, offering hope and healing to those who have sacrificed for their country. He said Gov. Tim Walz proclaimed May 28 as "Bravo Zulu House Day" and the proclamation itself reads it is a "beacon of hope for veterans nationwide.'

Votel said future plans include developing a specialized facility for female veterans, who face a 75 percent higher suicide rates due to military sexual trauma. The organization is seeking to raise \$1.25 million to fund lift and wheelchair-accessible rooms, dog kennels for the therapy program and the hydroponic farming system.

The grand opening coincided with Memorial Day week and featured a proclamation from Sen. Amy Klobuchar, read by her outreach director Chuck Ackman, as well as speeches from 1st District Congressman Brad Finstad and Mayors Jean Anderson and Lee Baarts, from Winnebago and Fairmont respectively.


