# Be the One!

### Nat'l commander spreads message of suicide prevention, second chances

LA CRESCENT — American Legion National Commander James A. "Jim" LaCoursiere Jr. came to Minnesota the last week of March with a message: "It's OK to not be OK, and you know that I am on your side."

Preventing veteran suicide, he said, is the top priority of The American Legion. He called on members to be compassionate about struggling veterans.

"Be the One," he said, "is not a campaign slogan. It is a mission."

LaCoursiere, whose home post is Moosup Post 91 in Connecticut, visited Forest Lake Post 225, Apple Valley Post 1776, Pine Island Post 184, La Crescent Post 595, Eyota Post 551, Faribault Post 43, Fridley Post 303, Buffalo Post 270, Paynesville Post 271, Granite Falls Post 69 and Slayton Post 64.



### **USS Saint Paul crew** seeks a memorial

The USS Saint Paul Association has initiated a fundraising campaign to establish a commemorative memorial in the state of Minnesota to honor the ship and the men

who served on her. The association is currently in the application process with the Capital Area Architectural and Planning Board (CAAPB) and hopes to achieve final approval for the project at the end of 2025.

Korea

The USS Saint Paul Association is sending letters to the post commanders of all Minnesota American Legion posts providing information on the fundraising campaign and requesting financial and letter support for the USS Saint Paul Commemorative Memorial. The process of memorializing the USS Saint Paul involves a period of public review of the proposal. We hope that American Legion members will join the (1,200 active association members) in encouraging state authorities to move forward with this memorial.

The USS Saint Paul was a storied ship earning 18 battle stars and firing the last rounds on the home islands of Japan ending World War II. She also fired the final rounds of the Korean War on July 27, 1953, and engaged in a record five deployments in

the Vietnam War. She holds the record for the most ordnance rounds (182,000) fired in combat fired by any naval vessel in the world.

From the time of the ship's christening in 1944 by the mayor's wife through its decommissioning in 1971 with a native Minnesotan as commanding officer, there has been a continuum of veterans (several hundred being from Minnesota including three commanding officers) who proudly represented the city of Saint Paul and the great state of Minnesota.

She wasn't on ican Legion Post 201 was being forced to pay \$7,000 in commercial property taxes even though it has no bar or banquet business. It is a veterans memorial next to a building with military depictions, existing solely on donations.

The story said Kanabec County Assessor Tina Von Eschen did not return calls from the Legionnaire inquiring why the post wasn't being taxed at 1 percent. Members of the post had told the Legionnaire the assessor granted a 1 percent reduction instead.

Von Eschen, in her response, said the Legionnaire did not tell her when the publication went to press.

The Legionnaire editor called her on a Monday. The paper went to press

- A story in the March on a Friday. Her staff also knew the vacation or sick, so five days is plenty of time to respond.

> Von Eschen claimed the Legionnaire totally made up that she would only grant a 1 percent reduction. The truth is that the Legionnaire attributed the comment to the Post 201 members, who all got that idea from Von Eschen herself in a prior meeting they had.

> The good news is that the local newspaper, the Kanabec County Times, took up the matter. Post 201 Commander Alan Skramstad says Von Eschen worked with Post 201 to reduce property taxes to 1.75 percent.

In 2017, he was campaigning to be national commander within two years when he was cited for driving under the influence and was facing a felony charge. His campaign was suspended and he lost his national chairmanship. He was in a deep, dark place and was suicidal.

"My team within The American Legion let me know that they were there to take care of me, to get me the VA treatment I needed," he said. "They stayed in touch, helped bond my family together, and, to this day, that is why I truly embrace our 'Be the One' mission."

LaCoursiere's last drink was Oct. 1, 2017. He was able to resume his campaign five years later and was elected national commander in New Orleans at the end of August 2024.

The national commander reminded audience members that everyone must strive to speak with each other, not just talk at each other.

'We must listen, not just hear. And we must see one another, not merely look at."

stands for "Loyalty, Unity, Valor." He spoke of his love for the Legion Family and wants young veterans to experience the same love so they can enhance the organization.

### Be the One app

LaCoursiere ended up doing 17 media interviews during the tour. His aide, Butch Hansen, said most statewide tours have only two or three. The commander called Minnesota's tour "top-notch" several times.

During his interviews, he encouraged people to get out their cellphones and download the "Be the One" app. It walks users through steps to prevent suicides of anyone, not just veterans. It is found on Apple's App Store and on Google Play. Just search "be the one."

"We can have the resources we need right at our fingertips at the moment we need them,'

The American Legion worked hand in hand with the Columbia Lighthouse Project to develop the mobile app.

"We do not jump on the His theme is L.U.V., which bandwagon. We want to have a complete dialogue with the key players," he said.

LaCoursiere said the Legion is very aware of the report of a projected 83,000 staff cuts from the Department of Veterans Affairs. That, he said, looks to be a working figure based on 2019 levels — prior to the 2022 passage of the PACT Act.

He said the administration will produce a report by the middle of April, then a review in mid-May, with a decision in

"We feel there still is time to work with Congress," he said. The American Legion is

watching to ensure health care of veterans and benefits are not impacted. He said the Legion believes that a staff reduction of 83,000 would leave the VA unable to service the veterans who receive VA health care via the PACT Act.

"We are asking Congress to keep their word," La Coursiere told the audience in La Crescent. "We want them to be smart about making these cuts. Do not mess with our health care, military benefits or veterans benefits."

He added: "We will fight

### **Applicant medical** reimbursement

There are times when military recruits (or their families) end up paying for the cost of required medical evaluations, which can be a deterrent to the enlistment process.

The commander and his aide will bring back to American Legion Headquarters in Indianapolis the feedback they received in meetings with officials. The problem of reimbursing medical evaluations was brought up by Maj. Gen. Shawn Manke, adjutant general of the Minnesota National Guard, and Lt. Col. Kristen Auge, director of strategic communications.

'Applicant medical reimbursement" is an effort to get the military to reimburse recruits or their families for those

U.S. Reps. Brad Finstad and Angie Craig introduced language in Congress last year that was included in the 2025 National Defense Authorization Act. It authorizes the secretary of defense for those reimbursements up to \$100. However, there was no funding tied to the program.

A similar bill was introduced by Sens. Amy Klobuchar and Todd Young (of Indiana).

Manke and Auge said recruiters for all branches of the armed forces would like members of The American Legion in Minnesota and nationwide to ask U.S. senators and representatives to fund "applicant medical reimbursement."

The Congressional Budget Office estimates the annual cost would be \$5 million.

Manke also spoke about lack of construction funding. He said the National Guard elements make up 20 percent of the U.S. joint forces. However, they only receive about 4 percent of the military's construction budget.

There are about 130 soldiers in the company, said Sgt. 1st Class Samuel Sherer. The Faribault Armory, he said, is able to accommodate 170.

LaCoursiere asked him and his full-time staff what soldiers in the company needed help with. The soldiers said some of their team who drill one weekend a month and two weeks in the summer struggle with finances. Others struggle with housing post-AIT or when under extreme duress from life's hurdles. There don't seem to be resources, they said, for recruits coming from difficult home situations.



but the boos were louder. This was followed by a veteran who heckled the governor over his military service, followed by another veteran who told that veteran to shut up.

This footage then made its way across social media platforms in edited clips.

"Fortunately, neither of those two veterans were wearing American Legion caps," said Randy Olson, a member of the Department Legislative Committee.

The American Legion is a nonpartisan organization, and its members strive to remain focused on veterans issues, not on party politics.

a member of Olson,

Winnebago Post 82, added it was strange to see young men walking around with T-shirts that said "Veterans Against Trump." This message of being for or against candidates is not what the CTF is about. He doubted whether they were part of any of the eight CTF organizations. They didn't watch proceedings from one place like Legion, VFW, DAV, PVA and other veterans did.

"They purposely walked around and puffed out their chests, as if to say, 'Read my shirt.' I don't bring my personal views to Veterans Day on the Hill. Neither should they.'

Moon said the CTF will address these issues at its May meeting.

Commissioner of Veterans Affairs Brad Lindsay spoke on how the House budget bill was cutting funding for veteran

homelessness. "Ending homelessness among veterans is a marathon, not a sprint," Lindsay said. "After many years of effort and support from the Legislature on the issue, MDVA is right at the finish line with our partners in Ramsey County. This budget will take us out at our kneecaps."

Ramsey is the last remaining area in Minnesota that hasn't declared "functional zero" in terms of handling veterans homelessness. If it does, Minnesota becomes the fourth state to reach this goal. The other three are Connecticut,

Delaware and Virginia.

Lindsay said the House budget hinders the MDVA in its staffing and operational needs at the three new veterans homes, resulting in empty beds at Bemidji, Preston and Montevideo.

The commissioner praised the past success of veteran omnibus bills and said veterans expect that to continue for years to

He said the MDVA supports the CTF's efforts to protect veterans from claim sharks.

"Let me be clear. This is about protecting veterans and ensuring that they keep every dime they have earned with their service," Lindsay said. "This is not about limiting their choice. This is about ensuring that they are making an informed choice and not feeding the very sharks that have been flying in from other states to feed in these hallways since the session started."

Moon's speech also pushed for passage of the claim shark bill.

"To my knowledge, 11 other states have passed claim-shark bills," he said. "The American Legion is pushing Congress to pass one, too. In the meantime, we need a claim-shark bill here in Minnesota."

Moon called for removal of property taxes for post homes of veteran service organizations and he called for the passage of the bill that adjusts property tax burden for disabled veterans for the first time in 14 years.

Legislative Department Chair Kristy Janigo spoke at the Armory. Later, she was the emcee at the Capitol. She also ran down the list of bills

sion: omnibus, property taxes and claim sharks.

"Some of my colleagues and in veteran service organizations have stories that would boil your blood about unaccredited parties taking advantage of veterans through aggressive marketing tactics for services they could have gotten for free from an accredited VSO representative," Janigo said.

# Suicide prevention becomes a very real story while in VA medical center

Hello, Minnesota American Legion Family!

As some of you know, I was quite ill, and I spent 16 days in the VA hospital. I have to voice my admiration and respect for the doctors and nurses, especially the nurses. While I was in the hospital, a veteran friend of mine and I were on the phone. He was on speaker, and he was saying that he was going to commit suicide. He just couldn't deal with life anymore.

A nurse was in the room and overheard the conversation. My friend lives in New Jersey and had been moving around to different housing situations, and I wasn't sure where he was exactly. I had conferenced in another friend of ours into the call and together we were trying to talk him out of his plan to kill himself.

The nurse asked me for his phone number and I quietly gave it to her. She contacted the VA police at the Minneapolis VA hospital, and they, in turn, contacted the VA police at the East Orange VA Medical Center, and they contacted the local police department who were able to locate my friend's phone.

Police in the city where he was dispatched a squad car and an ambulance to his location. The police officers talked to him and convinced him to get in the ambulance and go to the VA hospital and get some help with his PTSD issues and he agreed to go to get some help. The nurse saved my friend's life. I will be eternally grateful for the nurse at the Minneapolis Veterans Affairs Medical Center thank the Legion Family who

That nurse is a shining example of the staff at the VA hospital here in Minnesota. And I have to say that during my time at the VA hospital, the nursing staff was outstanding in every respect. And not just the nurses all of the other staff that I encountered during my time there were wonderful in their interactions with the veterans in the hospital.

I put the nurse in for a commendation for her actions to save my friend's life. My friend is receiving continuing treatment at his local VA and is getting the help that he needs to resolve his issues.

That is my personal story of 'Be the One." Sometimes, it takes more than one; it takes a team effort to "Be the One" to step in and stop veteran suicide.

I am in the process of my recovery from the influenza type A that made me so ill. It affected my heart and lungs. I had pneumonia in my right lung, and my heart isn't pumping effectively, but I'm on medication to help my heart work better. I want to thank all the members of the Legion Family who sent me getwell cards, called me and gave their wishes for a quick recovery from my illness and those of you who came to visit me.

I also want to personally

publicly thank Joe Jansen for his visit as part of that hospital visitation. When I was admitted to the hospital, there was a shortage of beds because of the influenza outbreak. There were veterans, myself included, who were sitting in the Emergency Room waiting for a bed to open.

The department service officer stepped up and went to the hospital administrator and pointed out the condition of those veterans waiting for a bed who were basically trapped in the ER on a gurney. This got us out of the ER and into a real bed in the hospital.

I am well on my way to a full recovery and am excited for the next few months as I finish my term as detachment commander. I plan on being at as many events of the Legion Family as I possibly can. I'm looking forward to seeing you all. Thank you all for your support and remember to "Be the One"!



Riders chapter provides "last ride" to a member with

# **Chapter 56 honors** a founder with ride around Fountain Lake

ALBERT LEA — More that a dozen members of Chapter 56 in Albert Lea, Minn., honor one of its founders with a ride around a local lake.

A 2010 American Legion Legacy Run stop hosted by Leo Carey Post 56 in Albert Lea, Minn., inspired Legionnaire Wes Halverson to start an American Legion Riders chapter four years later when he was serving as post commander.

He was joined in his effort by fellow Post 56 member and longtime friend Jim Hockinson, as well as another interested member. A chapter was formed, one that now can call close to 90 American Legion Family members as Legion Riders.

But after being diagnosed with terminal pancreatic cancer, Hockinson can no longer ride his motorcycle. That didn't stop Chapter 56 from getting him out on a bike one more time.

On July 24, more than a dozen Chapter 56 Riders took part in a procession that included Hockinson riding on the back of Halverson's motorcycle. The group picked up Hockinson at the Thorne Crest Senior Living Community, where he is under hospice care, and rode him around Fountain Lake.

"We talked, we laughed and we cried," said Halverson, who serves as Chapter 56's sergeantat-arms. "It was so hard. It was a hard thing, but it was a happy thing. I asked him, 'How are you doing?' And he said, 'Best day ever.' He was so happy. He said, 'I got my last ride. I finally got my last ride."

served together in the Minnesota give him a ride on the trike," National Guard for more than 20 Halverson said. "I said that I years and became good friends. And they were instrumental in starting Chapter 56.

"When I started the American Legion Riders chapter in Albert Lea, I didn't know anything about it," said Halverson, who at the time didn't even ride a motorcycle. "I was trying to figure out, 'How do I get the members back' – especially those veterans of the Vietnam War up to Gulf War and so on.

"I served in the military for almost 28 years, but I was never deployed. So, I could not communicate with those individuals that were deployed, that did combat service.'

He recalled the Legacy Run stop and started doing research on starting a chapter. "I had never ridden a bike. I had never had a (motorcycle) license," he said. "So, I put the message out in our newsletter ... that we were going to have a meeting. And Jim was the first guy that

walked through the door."
Halverson, Hockinson and another interested member -Arnold Anderson — worked for months promoting the program through local media. Now the chapter sits at around 90 members.

The chapter is very active, donating to various veteran-related organizations that include Quilts of Valor and Honor Flight. It has also bought the materials and then built a handicap-accessible ramp for a fellow Legionnaire's home, and gives out challenge coins at Christmas to veterans and spouses of veterans living in assisted-living centers and retirement homes.

The idea to provide Hockinson with being on the back of a motorcycle again came from a group ride. "We are down riding motorcycles in Savannah, Ill., about 14 of us," Halverson said. "While we were down there, we all got to talking about that we needed to do something for Jim. They'd given him a week to two

"I got back home, and I called another of our (charter) Riders (Dave Nelson) who was a good friend of Jim's. He did a lot in all this.

The pair both had the same idea: to give Hockinson a final ride on the back of a motorcycle. "I said, 'What if I brought my Halverson and Hockinson trike, we put him on there and would be honored if I could do that, because Jim and I had gone through so much together.

The original date for the ride was rained out, but the second day, the weather was perfect. The ride received both broadcast and print media coverage and was "wonderful," Halverson said.

"We just care so much about our chapter and our Riders," Halverson said. "This is our family. What we did for Jim, I can't explain how grateful I am to be able to do that for him. It was a wonderful thing to do for him. We did what we could for Jim.'


