## Son keeps father's legacy alive

Merrel L. Duncan of Dundee has returned from a mission aboard a B-17 Flying Fortress. He is back at his quarters at Bassingbourn in England, writing in his diary.

'Aug. 16. Target for today was a factory 3 1/2 mi. N.E. of Leipzig. It manufactured wings for Ju88s. We carried 10 500# clusters of incendiaries. We bombed from 24,000' temp -20°C. Flak was encountered quite heavy in spots, but at the target, we didn't get much. On oxygen for 6 1/2-7 hours. Almost all our oxygen was used up by the

for our first time since I started flying. We were in heavy flak + all of a sudden the flak stopped + bandits hit. They hit the ships in the high element right in back of us + to the left. There were ME 109s + FW 190s [Messerschmitt Bf 109 fighters and Focke-Wulf Fw 190 fighters]. They just laid up there + peeled off into the B-17s. I think the gunners were caught unaware because there was hardly a shot fired from the ships that went down. One ME 109 came past at 90°, + I fired about 150 to 200 rounds,

RED WING — It's 1944. Radio operator time we got back. We got enemy fighters so did Muscles + Umlor. He peeled over + went under our ship + exploded. They made just one pass, it lasted about 50 sec. if that long. On the one pass they got 8 of our B-17s. I saw one B-17 blow up another, another go down in flames, 2 others drop out of formation all afire. I saw one chute bail out delayed jump. Another looked like the fellow was almost gone. He hung like a rag doll. When we got back to the base we found out that Lt. Goods crew was one of the crews that was hit but he made it back.

# Slay the lava monster

## Gabe Keith was in Baghdad when the Saddam statue fell

TEST ST. PAUL — Gabe Keith of West St. Paul works in a fantasy, horror and science fiction bookstore. The Marine veteran is leading an effort to bring veterans who like to write together for a monthly writing workshop he calls Write Club.

The title is a play on words from the Brad Pitt thriller "Fight Club." The workshop encourages writing as therapy, and the idea is to have the group critique and improve their work.

Keith, 40, is a member of St. Paul

In his youth, Keith read science fiction and fantasy books, which often have military aspects, and he figured the Marines would provide him with the adventure he sought.

"It was a way to get out and be on my own," he said.

He graduated from Stillwater High School in June 2002, though he grew up in St. Paul. He said he was sheltered as a kid. He had an uncle who served in the Army during Vietnam as a door gunner on a Huey. His grandfather was in the Navy in World War II.

The Marines didn't recruit Keith. He approached the Marines as a result of a famous TV commercial out in the late

1990s and early 2000s.

A young man scales a big machine in the rain, pulls a Claymore sword out of a forge, slays a giant lava monster and turns into a Marine. The Marine Corps title the commercial "Rite of Passage." The Marine Corps infantry, he figured, would be his biggest challenge.

Boot camp was at MCRD-San Diego. School of Infantry was at Camp Pendleton. His duty station would be at 29 Palms, also called Marine Corps Air Ground Combat Center. He served in the 3rd Battalion, 4th Marines, 7th Marines Regiment — the Bastard Battalion.

Keith was a machine gunner. He barely had time at his new unit to zero his weapon before they deployed to Kuwait in February 2003. In March, the Bastards crossed into Iraq. Fantasy was about to get real.

e was part of a weapons platoon. In Iraq, his squad (a section of a Lplatoon) was assigned to a rifle platoon. His platoon had M16A4 rifles, M203 grenade launchers, M249 squad automatic weapons (better known as SAWs, and, from afar, they sound like a saw, too) and the M240G, a beltfed medium machine gun which fires 7.62 mm rounds. The 240 was Keith's

The 3rd Battalion had to engage Saddam Hussein's mobile infantry. They rolled behind tank battalions in AAVs, or Amphibious Assault Vehicle. Once an enemy's line was broken,

ST. PAUL — The Minneapolis VA was present for the ribbon cutting. Health Care System presented its new Mobile Medical Unit on Oct. 3 outside the Catholic Charities Opportunity Center in St. Paul.

Catholic Charities runs many of the efforts to shelter and care for the homeless or people at risk of experiencing homelessness in St. Paul and Minneapolis.

The VA's mobile unit will allow the agency to reach veterans in one of Catholic Charities' shelters or homeless veterans on the streets of St. Paul. It will be at 422 Dorothy Day Place in St. Paul from 10 a.m. to 2 p.m. every Tuesday.

St. Paul Mayor Melvin Carter

"This challenge requires big think-

ing and big partnerships," he said. He thanked the VA and Catholic Charities

"We need great organizations who are in the trenches with us," Carter added.

Sidney Patterson, an Army veteran who previously experienced homelessness, held the scissors that cut the ribbon. He described the places he has slept — abandoned buildings, inside cars, others — and said the mobile units for providing health care are a good idea.

### There is a national blood crisis at hand

Since the start of the pandemic, blood banks across the United States have been calling on eligible donors to come down and help stave off shortages. It's critical that blood banks have enough of a supply for local hospitals, which risk having to make hard choices about who receives immediate treatment and who must wait.

In the United States, every two seconds, a person needs blood or platelets, making it vital to have a lot banked. Blood is needed for everything from surgeries to traumatic injuries to cancer and sickle-cell disease treatments, with roughly 29,000 units of

6,500 units of plasma required on a daily basis. Blood and platelets cannot be made synthetically, making voluntary donations necessary.

Every year, only 3 percent of Americans donate blood, and at the start of the COVID-19 pandemic, that number plummeted. Blood drives at schools and clubs were canceled and donor centers were closed, and because of staffing troubles and rising costs, things still haven't gone back to normal.

In January 2022, the American Red Cross declared its first-ever blood crisis, after experiencing a 10 percent decline in the number of people donating.

About 60 percent of blood donations are

red blood cells, 5,000 units of platelets and from people who are 40 and older, and Katie Smithson with the Blood Connection stated last fall that "we're losing donors quicker than we're gaining donors. Part of that is due in fact to COVID. When COVID hit and schools went virtual, whether it be high schools or colleges, we lost about 30% of our donor base because we used to go to these schools and we couldn't anymore because the kids weren't there.'

in retirement as I partner with veteran organizations to advocate for advances in medical research toward a cure for ALS, a disease veterans receive a diagnosis of twice as much as the general population."

Walz and Herke served together in the Minnesota National Guard. Herke, at one time, was boss to Walz. As governor, he became boss to Herke.

In a press release distributed last month, Walz said: "As a veteran of the U.S. Army and Minnesota National Guard, Commissioner Larry Herke dedicated his career to serving our state and country. As commissioner, he worked tirelessly to make progress toward ending veterans homelessness, strengthening our veterans homes and cemeteries, and helping Minnesota's veterans and their families receive the best care and benefits. I am deeply grateful for his service and wish him well in his retirement."

Herke, a member of Sauk Centre Post 67, told the Legionnaire he wishes to bring attention to the higher rates that veterans end up with ALS than the general population.

Deputy Commissioner for Programs and Services Brad Lindsay is in the role of interim commissioner.

important this is. When you are homeless, the last thing you are thinking about is your health," he said.

Nationally, the VA is employing 25 new Mobile Medical Units, or MMUs.

Jonelle Glubke, director of the Minneapolis VA Homeless Programs, said the MMU represents a shift in thinking.

"What if we make it our responsibility to come to you?" she asked.

A news release from the Minneapolis VA states: "MMUs are vans or trucks that move from one location to another that can provide veterans with services such as health assessments and education, preventive care, referrals to VA homeless programs and other resources in the community. MMUs provide VA's Homeless Patient Aligned Care Teams, or HPACTs, staff with the necessary infrastructure to provide care in community-based settings, all in a safe and confidential space with medical supplies and equipment readily available. HPACT MMUs provide a one-stop shop for wrap-around services that are integrated and coordinated. engaging veterans in intensive case management, and providing high-quality, culturally sensitive health care."



## **Diary chronicles events** of 30 bombing raids

Their oxygen was shot out + they were at 24,000'. The 324 Squadron lost 7 ships + have only a few crews left. Pine bailed out over Germany + just before he went he called + said he was shot up bad so was going out. Tyson, got killed 2-20 mm in the head + 1 in the neck. Peters, got 1-20 mm in the ankle. He's in Cambridge Hospital at the present. They got back to this side but crash landed in Southern England. I never was so all in + shaken up in my life. I've Prayed every day that I've been here + I know it's the Lord who has seen us through this far. As I write date Aug. 16, 1944, for the first time today. I realize that this date is my 28th birthday + I've been given Grace by our Supreme Father to live."

Airman Duncan, a graduate of Fulda High School, survived 30 missions over Europe in World War II, with the 91st Bomb Group, 401st Squadron, based in Eastern England at RAF Bassingbourn. They were known as "The Ragged Irregulars."

In its first seven months of action, the 91st Bomb Group suffered 82 percent casualties and lost 41 of its original 48 aircraft. Duncan was among the few to survive. He recorded all of his missions in a small, 60-page, spiral-bound diary.

He began serving as a radio operator aboard the "General Ike" B-17. After a time, he became group lead radio operator, serving aboard various bombers. His last mission was aboard the "Tennessee Tess." He was a technical sergeant (E-6) by this point.

"Dad was always calm no matter how crazy and wild it got," said his son, Michael, who lives in Red Wing. "That was what was amazing about

Michael Duncan works to keep his father's legacy alive all these years later. Michael himself is a Vietnam veteran and a member of Red Wing American Legion Post 54.

After his father's death on Nov. 16, 1989, son Michael Duncan read the diary for the first time. He had it reprinted in handwritten fashion as a and completed his tour on Jan. 1, 1945.

limited edition on spiral-bound notebooks for the public to consume. It is titled "The Last Mission."

For four years in the late 1980s and early 1990s, Duncan combed the country talking to media outlets to find the aircraft called Tennessee Tess. He found a fellow in Florida who had flown with his father. The man had a photo of the aircraft. Duncan used the photo to prove its existence to federal authorities and historical societies. That photo is on the back of the reprinted diary.

The aircraft ended up in a boneyard and scrapped.

Duncan himself served in the Air Force, with the 9th Reconnaissance Wing, mainly flying into weather systems ahead of fighter groups. He was part of the crew on WC-130s. He served from January 1969 to January 1973. After he got out, he had a hard time getting a VA claim, but a woman working as a county veteran service officer helped him stick with it, and he won his claim.

"I owe her a debt of gratitude," he said. "It's a different VA now than it was back then.'


Duncan commissioned artwork in his father memory and, in November 1992, was part of a signing ceremony in Lake City. Called "The Last Mission," its artist is Bryan Moon. With them was retired Capt. R.R. Goldsmith, group lead pilot.


Duncan sells the limited prints to American Legion and VFW posts for \$100. The print normally costs \$150. It hangs in the entrance to the VA Medical Center in Atlanta. You can find one in at Post 54 in Red Wing. There is now one at The American Legion Department of Minnesota, too.

Merrell Duncan was from a family of five brothers and five sisters. His brother Earl was drafted. Earl was married, so Merrell — whose nickname was "Squirt" - volunteered to take his place. Squirt married his wife, Bonnie, in Fort Ord, Calif., before shipping out. She was from Heron Lake.

He arrived at Bassingbourn on July 2, 1944,

## Marines of 3rd Battalion return for 2nd, 3rd tours

they ensure the enemy stragglers could not refuel or flank the American tanks. Instead, they would get stranded and captured.

This resulted in skirmishes with enemies and shooting up enemy fuel

The Marines typically operated at night because they had a tactical advantage with the night-vision technology. They would take positions behind a berm, then attack enemy vehicles as they approached. Often, they were ragtag vehicles, like small pickups. The AAVs had a .50-cal mounted on top. Between the .50-cal and grenade launchers, they would take out the enemies well before they could get close.

The Marines secured bridges and towns on the way to keep supply lanes open for convoys. Then they took Baghdad.

"I was a block away when the statue of Saddam fell," Keith said.

The famous toppling seen around the world on television took place April 9, 2003. Keith and others were providing security at an intersection.

The 3rd Battalion was in the Iraq War for only four months. He got back May 24, 2003.

"Some people back home didn't realize we had left or saw combat,' Keith said.

His parents were supportive and, like a lot of military parents, didn't know what their kids were being sent into. Keith met up with a few friends and just relaxed.

"I spent a lot of time just doing nothing. I didn't really share at the time what I had gone through," he said.

Keith went back to California. His battalion had left all their weapons in Iraq for their replacements. Those replacements came from Okinawa, Japan. So, in February 2004, the Marine Corps, in its infinite wisdom, was flying his unit to Okinawa to get weapons from that Marine base.

After two months in Japan, the 3rd Battalion then went back to Iraq, arriving in April 2004 while the First Battle of Fallujah was nearing an end.

The 3rd Battalion created a perimeter around the city. However, his platoon was pulled out to be a reactionary element. Keith was a team leader by now.

They flew in Hueys, CH-46s and CH-53s to hot spots. For example, they would pop in and perform traffic stops on hostile vehicles. Some of the other units doing the same thing were special operations units.

"They didn't use us for the sexiest missions," Keith said. "They aren't going to send a Marine platoon for the most dangerous situations, but we always showed up for duty. My squad was reliable. We had to be available for every rotation."

They also were assigned to provide security for non-infantry convoys. For

convoy that ran across Haditha Dam on the Euphrates River.

"We supplied the front and rear security," he said.

On that one, his team and another team handled the front. They ran ahead to a trouble spot where the road went between two hills. They somehow missed driving over a pothole that turned out to be a bomb and, instead, a supply truck hit it.

Five months in country, and by July 2004, the 3rd Battalion returned home.

"I went back to Minnesota. I just tried to spend as much time with friends and family as possible," Keith said.

Then he went UA. UA is unexcused absence. It's the equivalent to the Army's AWOL. He missed formation for 25 days. And he wasn't the only one.

"There were talks we were going to go back because of elections," Keith said. "It became apparent they were going to remove our leave to ensure we would prioritize training for going back to Iraq."

If he had been gone for 30 days, the Marine Corps would have considered him a deserter. He was busted down from E-3 to E-1. The 3rd Battalion returned to Iraq for a third time in January 2005.

During Vietnam, soldiers volunteered for second and third tours. Those days were long gone by the time of the Iraq War. Tours are mandatory. In a volunteer military, once you say the oath, you belong to Uncle Sam.

These Marines provided roadside security and ran patrols. The U.S. military had problems with improvised exploexample, one was an Army supply sive devices not being detected and

insurgents ambushing convoys. The insurgents thought they were winning.

The 3rd Battalion's job was to find them and convince them otherwise.

"We go in and break their spirit,"

They conducted foot patrols, and, if shot at, they would lay down a base of fire, then an element would break off and take out or scare off the enemy.

n July 25, 2006, Keith got out of the Marines with an honorable discharge. He moved in with an aunt named Mary Keith who lived in a park reserve in Illinois. Unfortunately, she soon was diagnosed with ALS, better known as Lou Gehrig's disease, so he took care of her for a year until she needed better care.

"She had been the one who got me into reading and writing years before," Keith said.

Specifically, the novel was "The tasy by Terry Brooks. It's the first in a trilogy. He read it when he was 9 or 10. ing him the ropes.

Then Keith moved around a lot. He lived in Arkansas, Las Vegas, Tampa Bay area of Florida.

"I always kept coming back to Minnesota."

He got his degree in public safety specializing in criminology from Capella University in 2012. He wrote his military memoir while in Vegas. The 2017 self-published book is called "Little Warrior Brother."

He returned to Minnesota near the beginning of 2021 during the pandemic. His real estate agent was an Army veteran and Legionnaire. The agent helped Keith purchase his home in West St. Paul. A year later, he asked Keith to join and have a drink. Keith had quit drinking in the meantime but, in fall 2022, happily joined St. Paul 3M Post 599 and hung out.

"I thought the Legion was a series of bars and that it revolved around events, and I didn't know it had a greater purpose until I started talking to Teresa Ash," Keith said.

Ash is heavily involved in the 4th District and has been a department vice commander and historian. She presently is the 4th District commander.

"The first thing she asked is 'What is it you know about The American Legion?" he said.

She explained the various programs, how the Legion secures veterans benefits, helps them with claims and raises funds for good causes.

He had been in his home too much and thought it was good to get out and meet other veterans. He said he had become "a creature of my routines."

> arlier this year, Keith attended Post 8's meeting at Joseph's Grill ✓on Wabasha Street south of the river. He transferred posts because their meeting site is closer to his home and work. He works at Other Skies Weird Fiction, at 803 Dodd Road. (Its website is otherskies.ink.)

Keith also signed his stepfather up to join Post 8.

He found himself without a car after his, a 2014 Chevy Traverse, was stolen from outside a gym. As a new homeowner, he didn't have credit available for another. Minnesota American Legion Department Service Officer Ray Kane signed over his own car, a

2009 Hyundai Sonata in need of repairs, to him for free. The American Legion Minnesota Veterans Assistance Fund (Fund 85) paid for the mechanical repairs, not the hail-damaged body.


"I can't thank Ray and the Legion enough," he said.

Keith attended the October session of Minnesota Legion College at Camp Ripley and encourages other to attend.

We need young veterans so the Legion can get our veterans benefits to the next generation," he said.

#### An excerpt from "Little Warrior Brother," a stream of consciousness found on pages 197 and 198:

"One general told us, in a speech before our second deployment, that we needed to go over there and be capable of handing candy to kids one moment and turn to shoot an insurgent the next. He said we needed to win hearts and minds. But we didn't have a degree in psychology. We were kids. That speech wasn't for us. It was for his friends and the American public. That speech was the same reason they sent us to Iraq, the same reason they said the Towers were attacked, and the same reason they do anything they feel needs to be done. It's because we can't handle the truth. They weren't conditioning us for combat. They were conditioning the American people. I have no idea what the general even meant. Do you think he ever had to operate in a combat zone under that kind of pressure? I doubt it. The world believed he lived in was a lie. He was He's now the 4th District adjutant. making everyone back here believe that lie. No one has those standards for themselves. But now they all treat us like we're somehow different. We slip off their consciousness, like when you watch a movie that's so pathetic you can't remember how it ends. Their thoughts are BS."

'It's war that's BS. We go over there to kill MFers. Hearts and minds, my ass. It's going to get easier, Gabe. There is a light at the end of a tunnel, there really is. You're not losing your mind. Don't let these civilians get to you. They're idiots, just immature and idealistic. Let them talk. I know it bothers you because they believe their opinions are truth and because rationalizations can translate into actions even though you and I know they're just empty words. Then again, it's OK. They're not your problem."







## **Emmons dedicates Huey in Veterans Mem. Park**

EMMONS — Crews placed a decommissioned vintage Bell UH-1 Iroquois utility helicopter from the Vietnam War, also known as a Huey helicopter, into its place on Sept. 27 at the Emmons Veterans Memorial Park.

The helicopter was purchased and transported to Emmons in December. The park also includes three flagpoles with the United States, Minnesota and POW flags, silhouettes of service members on the corners of the park and a veterans memorial with names of over 400 area veterans dating back to the Civil War, World War I, World War II, the Korean War and Vietnam War all the way up to Desert Storm, Operation Enduring Freedom and Operation Iraqi Freedom.

A dedication ceremony took place Sept. 30, with 1st District American Legion officials

Aside from the Huey, the park's veterans monument was unveiled to the public in May, with a crowd of supporters gathering to see. Clair "Dag" Dagestad, member of Emmons Post 317 and president of the Emmons Veterans Memorial Committee, thanked community members for their support of the project, which has been underway since 2018.

He thanked other committee members: Larry Rasmusson, Paul Henschel, Mark Heggestad and Jerry Thompson. Thompson is the commander of Post 317. Rasmusson and Henschel are members. Haggestad is the adjutant of Squadron 317.

The monument was unveiled by Purple Heart recipients Al Larson and Gary Honsey, both Post

## Come to the convention for charities

ST. CLOUD — Allied Charities of Minnesota's 32nd annual convention takes place at the River's Edge Convention Center in St. Cloud Nov. 16-17.

Early bird registration is over, but registration remains open.

There will be over 30 classes on charitable gambling.

Importantly, there will be a townhall meeting on electronic pulltabs from 3:30 to 5 p.m. Thursday, Nov. 16.

ACM has held e-tab townhall meetings around Minnesota since last spring, when the state Legislature passed a law to make e-tabs less entertaining, claiming they were in conflict with tribal casino monopoly on slot machines because of the "open all" button. Lawmakers also provided a very slight amount of tax relief. Minnesota remains the state with the highest taxes on charitable gambling.

The Minnesota American Legion stands firmly opposed to scaling back e-tabs.

The funding from e-tabs helps struggling veterans in many ways, said Department Legislative Chairwoman Kristy Janigo. Losing the funding hurts the ability of veteran service officers with counties and with the Legion and VFW to help them.

"Harming veterans is a non-starter for me," Janigo said. "Minnesota has to fix this."

There is a big difference between how slot machines operate and electronic pulltabs. Slot machines have variable prize structures, jackpots and unlimited bets. E-tabs never have. E-tabs in Minnesota, even before the 2023 changes in law, already were more restrictive than other states.

E-tabs have helped charities statewide raise additional funds as the price of everything goes up.

### WELCOME HOME



Since January 2019, North St. Paul Unit 39 has assembled Welcome Home Bins for Veterans who have overcome homelessness through the Minnesota Assistance Council for Veterans. In four years, 350 bins have been donated. They contain sheets, pillows, blankets, towels, person care items, laundry supplies, kitchen supplies and items needed when setting up a home. Each bin costs \$180 to \$225 depending on the needs. Unit 39 has three or four fundraisers a year to pay for the bins. By August 2023, the supply was depleted, and the unit reached out for help from Post 39. 
