To date, from the inception of the program, FY2021, we have assisted 171 veterans with over \$442,000 in direct assistance to our Minnesota veterans. This is not a hand out but assistance to our veterans and their families who are going through rough times. We can all relate at some time in our lives when we could have used a little help. The Assistant Department Service officer (ADSO) and Department Service officer (DSO) review every case submitted to department and they work with the post investigator validating the veteran and their family is needing our assistance.

In a couple of the cases submitted to us, they have found after reviewing bank statements, the applicant has the funds to pay the overdue electric bill, or rent, or whatever they're asking assistance for. Rest assured the ADSO and DSO are great stewards of how the funds from Fund 85 are paid out and they have other resources for sustainability of our veterans. The success of

Our department has ap-

proached a time of change. We are having posts turning in their charters, five to date in 2025, posts selling their post homes and membership in a constant decline. Our membership in 2015 was 84,000. As of 3 June 2025, we are at 52,489.

I was at the national Spring Meetings in May, and at the adjutants' meeting, it was briefed the average age of our membership is now 70 years old. I ask, who is going to fill these shoes? Who will be there to lobby for our benefits and stop our local, state and national elected officials from taking our benefits we have earned away from us?

When new ailments arise from our service to our country, and we are exposed to toxins that cause the sickness, who will be there to add that sickness to presumptive conditions for disabled status? We need our younger veterans to step up, join our ranks and seasoned legionnaires need to mentor these young members. If we don't go and seek out our young veterans and explain why they should join our organization, we will have difficult time surviving and having a powerful voice with our elected officials.

I have heard many times from a young veteran, "What's in it experienced staff and a very have been utilizing these proknowledgeable staff with having over 70-plus combined years of committed service to your department. We continue to try ways to communicate to our members through electronic means by email, websites and social media. Postage continues to rise and is killing our budgets. ## Membership

We had a great plan in place this year focused on "Accountability, Communication and Transparency." Nothing is more important than those three concepts, and Commander Moon and I really wanted to spread that far and wide. We started the year out as always, in the top 10 in the county, but unfortunately, we started The Slide.

We have the ability to stop this each year, but somehow it just doesn't get done. We need to use the tools we have and go for it! Everyone keeps talking about getting our younger veterans into the Legion, so let's do it! We have tons of colleges and universities that have Student Veteran Resource Centers that are ripe for the picking.

I have gone to seven colleges and technical schools to talk with our younger veterans and always had positive experiences. Most of them don't even know about The American Legion and how we started the G.I. Bill. As I was sitting and talking with them, they decided it was a great idea and joined their local post. It was so easy!

Another great resource is the armories around our state, with thousands of young soldiers and their families who need to be educated about The American Legion. Most of them don't even realize that they count as veterans under the Legion's definition. Let's educate them.

Go to their family events and show them who we are and what we do. They are hungry to get involved in their communities, and the Legion is the perfect way to do that. Host activities at your posts for the young families and pull them into the fold. Picnics, cornhole tournaments, carnivals, dart contests, etc. Use our social media accounts to advertise and connect with them! We must modernize how and what we say to them by highlighting how we support mental health, job placement, VA benefits, and advocating for our benefits in Washington, D.C. We can also partner with our local veteran organizations like the VFW, DAV, etc. Younger veterans also love their cellphones, and there are a couple of programs out there that let you send mass text messages to members who have let their memberships lapse. One of our most powerful tools is MyLegion.org. I've taught several classes on it throughout the state, and the feedback has been fantastic. It's intuitive and incredibly helpful for membership management.

Sure, some older members are reluctant to use it, but that's OK - find someone in your post who is comfortable with technology and let them lead. Another major hurdle we're facing is the issue of upside-down posts — those that charge less for dues than the actual cost of membership. This model just isn't sustainable.

Right now, we still have 52 posts in this situation. That's down from 98 at the beginning of the year, which means we've made real progress. That's a win in my book!

One of the highlights of my year was traveling with National Commander James LaCoursiere. What an inspiring leader! His passion for the American Legion is contagious. Together, we toured southern Minnesota and visited posts I had never been to before. Sharing the message of "Be The One" - focused on suicide prevention and support - was truly impactful.

As we close out the year, we're sitting at 91.4 percent membership. We still need 4,881 members to reach our 100 percent goal. That may sound like a lot — but it's doable. Use the lists of 1982AD and 1982 members. Make the phone calls. Check in on our fellow veterans. Welcome them to your post. Show them that they belong and that we care.

This has been an amazing year, and I'm proud of the work we've done together. But there's more to do. Let's finish strong and keep the momentum going into the next chapter. I want to thank all the department vice commanders, district commanders and membership directors! You are all amazingly hard workers, and I really appreciate you!

Let's have fun. Let's "Be The One." Let's go for it!

## Chaplain

The chaplain position in any organization can be a barrier or a valuable asset to the leadership team. Requirements to provide spiritual support, prayers and presence for awareness that we are mind, body and spirit as humans are contained within the Officer's Guide and Manual of Ceremonies.

Page 16 notes: "The chaplain need not necessarily be a clergyman, but must be a person capable of moral and intellectual leadership and one who gives dignity and respect to the office. The chaplain should be in close touch with the commander and other post officers and should attend all meetings of the post executive committee. The leadership in many post activities belongs by right to the chaplain, and when this office is filled by the right person, the post's usefulness to the community greatly increases.'

In 2024, the Spotlight on Spirit podcast hosted through the Department of Minnesota American Legion (riverside pnc dan ludwig legacy may 9, 2024 001 sos legacy 1) began. Although not the responsibility of the Department Chaplain, its aim is to highlight how who we are as spiritual beings is demonstrated in what we do. It also brings to light how the different religious denominations differ; have as their common goal to define purpose and have a relationship with God.

I ran for this office to bring to the Department of Minnesota American Legion a Chaplain Manual. This will be provided for the Department Executive Committee's adoption before my term is completed in July 2025. #### Advantageous for the Body

Every two seconds, someone in the U.S. needs blood. Three people out of 100 donate. Spring into action to change this stat! More blood donors are needed to help patients.

Legislative

It was an honor to again serve as vour Legislative chair, along with committee members Alexandra Fleming, Logan LeClaire and Douglas Borgeson. All four of us work veteran benefits claims for our day jobs. CVSOs and GVSOs know veteran law at the local, state and federal level intimately, and we know when the law is not functioning well enough to deliver the benefits our veterans deserve.

We brought back our social mixer for a second year in a row, the week before the start of the legislative session at Mancini's in St. Paul where we invited every state lawmaker to come down to talk with us about our issues over appetizers. We did not have to work as hard to garner interest from lawmakers. We simply invited all via email, and they showed up! Legislators from opposite sides of the aisle took selfies with one another in front of our Legion logo VIP wall and showed an element of collegiality that unfortunately deteriorated later in the session, with the power struggle over the majority in the House for the first few weeks of session. But we know helping veterans is an area of agreement for most.

We also got down into the trenches more than we have in the past and utilized our Voter Voice tool more broadly. We wrote out bill language for every issue on our legislative platform, contacted lawmakers we thought would make good chief authors, and wherever possible, aligned bipartisan slates of co-authors to maximize support. Then, we called and emailed committee chairs to request hearings and contacted lawmakers to request their support whenever a vote was imminent. We had a Voter Voice campaign aligned to each platform priority and each related bill. We sent thousands of messages to state representatives, state senators, the governor and lieutenant governor.

We had several key accomplishments this year. Our CTF priority to address food insecurity across Minnesota was successful, with \$300,000 of new funding designated to LSS CORE to provide free meal services to veterans in need outside of Hennepin, Ramsey and Anoka (which is already covered by Metro Meals on Wheels).

For a while, we thought we were going to lose \$5 million of veteran homelessness funding, as the House Veterans Omnibus Bill cut this funding, while the Senate funded it at normal levels. In conference committee, the funding was restored, and we should soon be able to continue the work with our state homeless programs as usual and hope to reach an effective end to veteran homelessness across Minnesota, with Ramsey being the final county to reach the milestone. We brought major awareness to veteran benefits fraud with our claim sharks bill. The bill was met with much misinformation and misunderstanding, perpetuated by national lobbyists, hired by claim sharks such as Veteran Benefits Guardian. We believe the foundation is strong to successfully pass a Minnesota claim sharks bill in 2026. I'd like to thank everyone who traveled to Washington,

D.C., for the Washington Con- Moon for this appointment. ference. Each year, I bond with those who travel as we work together to navigate meaningful conversations with our members of Congress. I wish my successor Paul Hassing the best of luck in this role, as I step away for other things. I am super grateful for all the opportunities I had for the past three years.

for American Legion Baseball in 2024, and we are looking forward to a similar year for 2025. We have over 405 teams registered, a new record, but we landed on 377 after rosters were turned in. (The next largest department was Pennsylvania with 281 teams, followed by Nebraska at 276.)

One of the biggest challenges the Baseball Committee faces is the teams that decide to register late. This causes scheduling and planning issues throughout the entire program.

A major challenge we have faced in recent years has been rising costs of housing players and coaches in hotels during state tournaments. This made hosting especially expensive for cities in Greater Minnesota. This offseason, we increased the housing radius to 60 miles and improved the terms of our contracts with tournament hosts.

The biggest change to our Baseball Committee for this season is that Marshall Dalziel of Wayzata became our new registration coordinator, taking over for Vice Director Brandon Raymo. Last season, Jack Strong of Buffalo became our new director for the Division I Junior State Tournament, replacing Past Director Mike Perry.

The 2025 season will have five champions from 2024 hoping to repeat. Farmington will look for its second consecutive title in Division I Senior, as will Becker in Division I Junior, Holdingford in Division II Junior, while Sleepy Eye in Division II Senior seeks a threepeat. Holy Family of Victoria in Division I-A will be looking for its second straight title.

State tournament hosts for 2025 are: St. Michael for DI Senior, Bloomington for DI Junior, Ely for DII Senior, Hayfield for DII Junior, and Burnsville for DI-A.

Thank you to the districts that have already taken initiative by visiting facilities and providing much-needed items. This work is vital — and it reinforces that supporting our veterans should be a statewide effort, not just the responsibility of this committee. In the future, we hope to explore using a portion of the VA&R budget to help offset costs incurred by district efforts.

#### Communication & Collaboration

We welcome and encourage feedback from the entire American Legion family. Your ideas and involvement are critical to our success. Our committee may only consist of five members, but by working together with Legionnaires, Auxiliary members and the SAL, we can create a more powerful and united force for change.

We've committed to holding committee meetings at 7 p.m. on the first Sunday of each month, primarily via Zoom. Additionally, we aim to meet in person at least once per quarter, preferably around department rallies or other major events, as we believe face-to-face discussions are essential for deeper, strategic conversations.

#### Looking Ahead
